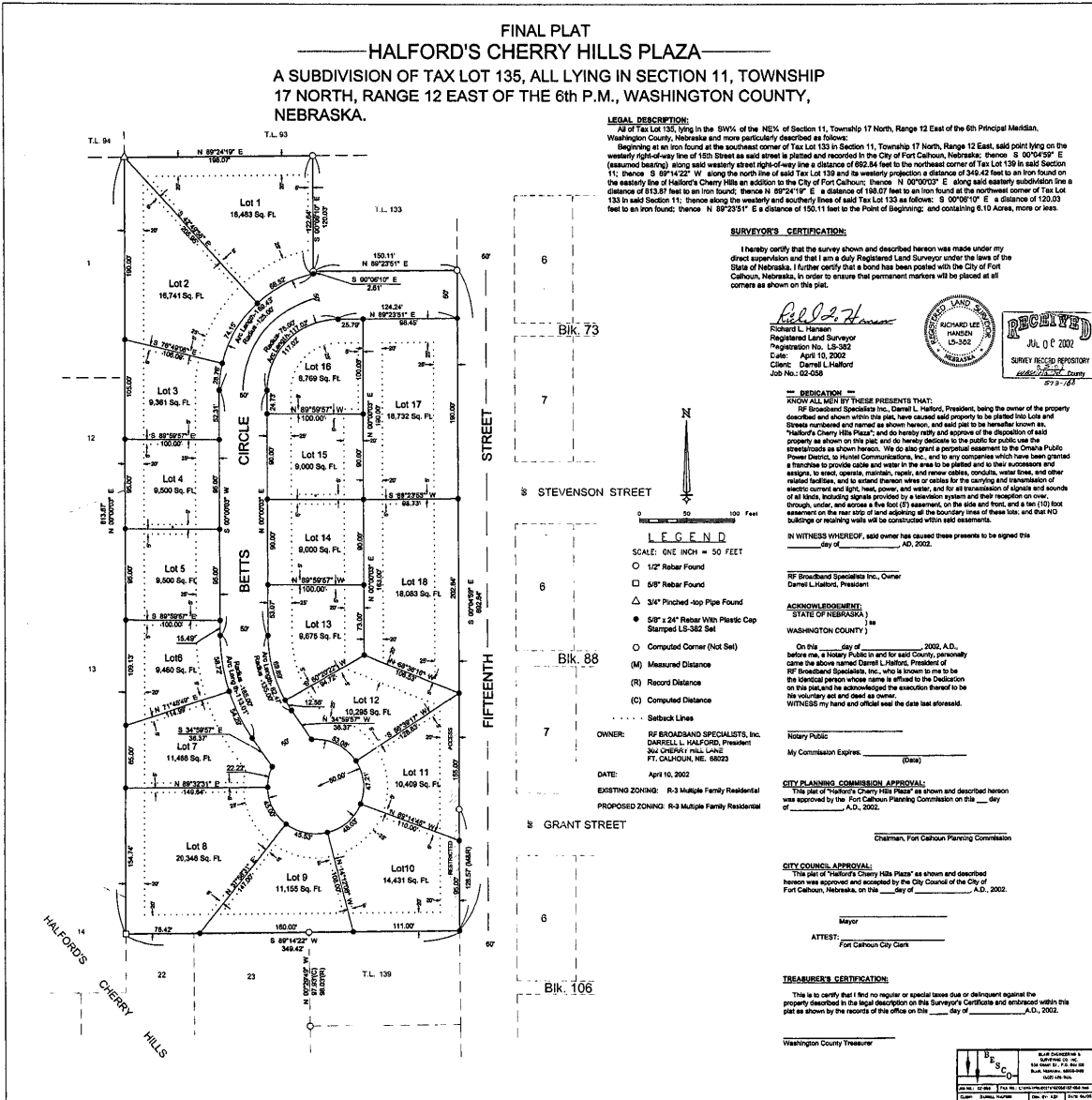


FINAL PLAT
HALFORD'S CHERRY HILLS PLAZA
 A SUBDIVISION OF TAX LOT 135, ALL LYING IN SECTION 11, TOWNSHIP

LEGAL DESCRIPTION:
 All of Tax Lot 135, 1/4 in the SW1/4 of the NE1/4 of Section 11, Township 17 North, Range 12 East of the 6th Principal Meridian, Washington County, Nebraska and more particularly described as follows:
 Beginning at an iron found at the southwest corner of Tax Lot 133 in Section 11, Township 17 North, Range 12 East, said point being on the westerly right-of-way line of 150' Street as said street is platted and recorded in the City of Fort Calhoun, Nebraska; thence S 00°04'59" E (assumed bearing) along said westerly street right-of-way line a distance of 692.84 feet to the northeast corner of Tax Lot 139 in said Section 11; thence S 07°14'22" W along the north line of said Tax Lot 139 and its westerly projection a distance of 345.42 feet to an iron found on the easterly line of Halford's Cherry Hills an addition to the City of Fort Calhoun; thence N 00°00'00" E along said easterly subdivision line a distance of 613.87 feet to an iron found; thence S 89°24'19" E a distance of 168.07 feet to an iron found at the northwest corner of Tax Lot 133 in said Section 11; thence along the westerly and southerly lines of said Tax Lot 133 as follows: S 00°08'10" E a distance of 120.03 feet to an iron found; thence N 88°23'51" E a distance of 155.11 feet to the Point of Beginning; and containing 8.10 Acres, more or less.
