See Exhibit "A", attached hereto and made a part hereof.

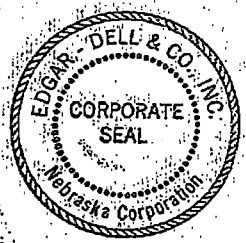

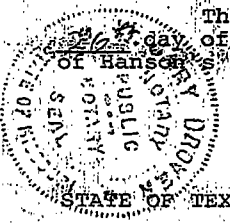

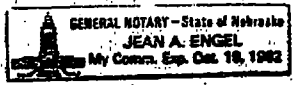
