RESOLUTION NO. A- 79644

SPECIAL PERMIT NO. 1502A

1 WHEREAS, Patrick Mooberry has submitted an application designated as  
 2 Special Permit No. 1502A to amend Hartland Homes East Community Unit Plan to delete  
 3 the recreation plan and the development and occupancy schedule requirements on  
 4 property located at 80th Street and Old Cheney Road, and legally described to wit:

5 All of Hartland Homes East, Hartland Homes East 1st,  
 6 Hartland Homes East 2nd, and Hartland Homes East 3rd  
 7 Additions, Barrington Park, Barrington Park 1st, and Barrington  
 8 Park 2nd Additions, and Barrington Park Townhouse Addition,  
 9 Lincoln, Lancaster County, Nebraska;

10 WHEREAS, the real property adjacent to the area included within the site  
 11 plan for this amended community unit plan will not be adversely affected; and

12 WHEREAS, said site plan together with the terms and conditions hereinafter  
 13 set forth are consistent with the intent and purpose of Title 27 of the Lincoln Municipal  
 14 Code to promote the public health, safety, and general welfare.

15 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of  
 16 Lincoln, Nebraska:

17 That the application of Patrick Mooberry, hereinafter referred to as  
 18 "Permittee", to amend Hartland Homes East Community Unit Plan to delete the recreation  
 19 plan and the development and occupancy schedule requirements, on the property legally  
 20 described above, be and the same is hereby granted under the provisions of Section  
 21 27.63.320 and Chapter 27.65 of the Lincoln Municipal Code upon condition that

1 construction and operation of said community unit plan be in strict compliance with said  
2 application, the site plan, and the following additional express terms, conditions, and  
3 requirements:


4 1. This permit approves an amendment to the Hartland Homes East  
5 Community Unit Plan to delete the recreation plan and the development and occupancy  
6 schedule requirements.

7 2. Except as amended by this resolution, all terms and conditions of  
8 Special Permit No. 1502, shall remain in full force and effect.


9 3. The terms, conditions, and requirements of this resolution shall be  
10 binding and obligatory upon the Permittee, his successors, and assigns. The building  
11 official shall report violations to the City Council which may revoke the special permit or  
12 take such other action as may be necessary to gain compliance.

13 4. The Permittee shall sign and return the City's letter of acceptance to  
14 the City Clerk within 30 days following approval of the special permit, provided, however,  
15 said 30-day period may be extended up to six months by administrative amendment. The  
16 City Clerk shall file a copy of the resolution approving the special permit and the letter of  
17 acceptance with the Register of Deeds, filing fees therefor to be paid in advance by the  
18 Permittee.



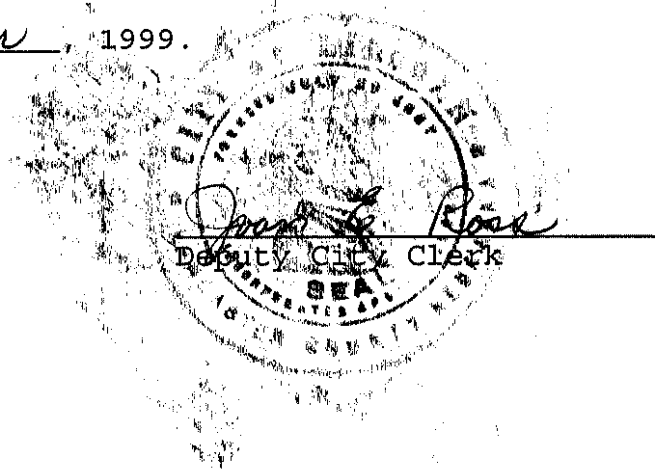
