CONSTRUCTION EASEMENT

For and in consideration of Twenty-eight dollars and Five cents (\$28.05) and other good and valuable considerations, the receipt whereof is hereby acknowledged, Gladys Marie Fornoff and Walter E. Fornoff (Husband and Wife) of Rural Route # 3 - Omaha, Nebraska 68123, Grantor does hereby grant, convey and release unto the Board of County Commissioners of Sarpy County, Nebraska, Grantee, its successors and assigns, a perpetual easement in, over and upon the following described land situated in the County of Sarpy, State of Nebraska, to wit: Approximately 1.4 acres located in NE 1/4 of SE 1/4 - Section 8, T. 13 N, R. 13 E, for the purpose of or in connection with construction, operation, maintenance, and inspection of a Grade Stabilization Structure, designated as site S-27 in the plans for Papillion Creek Watershed, for the flowage of any waters in, over, upon, or through such structures; and for the permanent storage and temporary detention, either or both, of any waters and sediment that are impounded, stored or detained by such structure and to include a site where suitable borrow materials may be obtained for construction.

The rights and privileges herein granted shall be subject to the following terms and conditions:

1. The consideration recited herein shall constitute payment in full for all damages sustained or to be sustained by the Grantor by reason of the construction, operation, maintenance and inspection of the works of improvement described above.
2. In the event construction on the above described works of improvement is not commenced within eight years from the date hereof, the rights and privileges herein granted shall at once revert to and become the property of the grantor, his heirs and assigns.
3. The grantor shall provide the grantee with ingress and egress as required to carry out the provisions of this easement.
4. There is reserved to the Grantor, his heirs and assigns, the right and privilege to use the above described land of the Grantor at any time, in any manner and for any purpose not inconsistent with the full use and enjoyment by the Grantee, its successors and assigns, of the right and privilege herein granted.
5. The grantee is responsible for operating and maintaining the above described works of improvement.
6. This easement shall not pass nor shall the same be construed to pass, to the Grantee any fee simple interest or title to the above described lands.
7. There is reserved to the grantor his heirs and assigns the right and privilege during the existence of this easement to cross any portion of the land described here in for the purpose of transporting farm machinery and equipment from one side of the easement to the other.

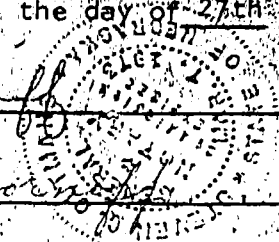
