GRANT OF EASEMENT AND MEMORANDUM OF AGREEMENT

THIS GRANT OF EASEMENT is made this 1st day of May, 2012, by and between Heritage Condo Association ("Grantor") and Cox Communications Omaha, LLC, a Delaware limited liability company, d/b/a Cox Communications ("Cox"). Grantor, for itself, its successors and assigns, does hereby covenant and agree with Cox, and its successors and assigns, that Grantor at the time of execution of this Easement has the good right, title and authority to grant this Easement, and that Grantor and its successors and assigns further covenant to warrant and defend said Easement against the lawful claims of all persons whatsoever.
