ORDINANCE 1279

AN ORDINANCE TO ANNEX CERTAIN REAL ESTATE TO THE CITY OF PAPIILLION, NEBRASKA, AND TO PROVIDE FOR AN EFFECTIVE DATE THEREOF.

BE IT ORDAINED by the Mayor and City Council of the City of Papillion, Nebraska, as follows:

Section 1: The real estate legally described as follows, to-wit:

Lots 1 through 52, Barrington Place, a subdivision surveyed, platted and recorded in the SE1/4, Section 34, T14N, R12E of the 6th P.M., Sarpy County, Nebraska together with adjacent public street right-of-way.

Section 2: The real estate legally described as follows, to-wit:

Lots 1 through 143, Hickory Estates, a subdivision surveyed, platted and recorded in part of Tax Lot 8, in E1/2 of the NE1/4, Section 23, T14N, R12E of the 6th P.M., Sarpy County, Nebraska together with adjacent public street right-of-way.

Section 3: The real estate legally described as follows, to-wit:

Lots 1 through 40 and Lots 99 through 168, Summerfield, together with Lots 169 through 223, Summerfield Replat, subdivisions surveyed, platted and recorded in part of the S1/2 of the SE1/4, Section 23, T14N, R12E of the 6th P.M., Sarpy County, Nebraska together with adjacent public street right-of-way.

be and the same is hereby annexed to and included within the boundaries and territory of the City of Papillion, Sarpy County, Nebraska, not again annexing any part thereof heretofore annexed, and the corporate limits of said City are hereby extended accordingly; and said lands and persons residing thereon shall thereafter be subject to all the rules, regulations, ordinances, taxes and other burdens and benefits of the other persons or property included within the City of Papillion, Nebraska.

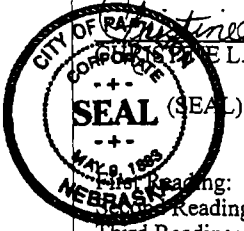
Section 4. Effective Date. This ordinance shall be in full force and effect fifteen (15) days after its passage. The city clerk is directed to effectuate the publishing of this Ordinance for at least one (1) week in a newspaper published within the City of Papillion, which publication must take place within fifteen days of the passage of the ordinance by the city council.
