### ORDINANCE NO. 1126

AN ORDINANCE TO ANNEX CERTAIN REAL ESTATE TO THE CITY OF PAPILLION, NEBRASKA, AND TO PROVIDE FOR AN EFFECTIVE DATE THEREOF.

BE IT ORDAINED by the Mayor and City Council of the City

of Papillion, Nebraska, as follows:

Section 1: The real estate legally described as follows,

to-wit:

# 1. SID 89 - PAPILLION INDUSTRIAL PARK

TOGETHER WITH THE FOLLOWING DESCRIBED PROPERTY: LOT 69, OAK HILLS OF PAPILLION, A SUBDIVISION SURVEYED AND PLATTED IN SARPY COUNTY NEBRASKA.

#### 4. SID 135 - HICKORY HILL II

Beginning at the existing city limits at the Southwesterly corner of Lot 44 of Hickory Hill II; thence Northerly along the rear lot lines of Lots 44 through 57 to the Southerly right-of-way line of Centennial Road; thence Easterly along the Southerly right-of-way line of Centennial Road to a point opposite the East right-of-way line of Rogers Drive; thence Northerly to a point on the North right-of-way line of Centennial Road at the East right-of-way line of Rogers Drive; thence Easterly along the North right-of-way line of Centennial Road to a point opposite the Easterly right-of-way line of Magnolia Drive; thence Southerly across Centennial Road to the Southerly right-of-way of Centennial Road at the East right-of-way line of Magnolia Drive and the Northwest corner of Outlot 2; thence Easterly along the North line of Outlot 2 to the West right-of-way line of 72nd Street;

thence Southerly along the West right-of-way line of 72nd Street to the Southeasterly corner of Lot 185; thence Westerly along the Southerly lot lines of Lots 185 through 176, across Magnolia Drive, along the Southerly lot lines of Lots 175 through 169, Lots 113 to 110 and Lot 36, across Valentine Lane, and along the Southerly lot line of Lots 37 through 44 to the existing city limits and point of beginning;

being the same is hereby annexed to and included within the boundaries and territory of the City of Papillion, Sarpy County, Nebraska, not again annexing any part thereof heretofore annexed, and the corporate limits of said city are hereby extended accordingly; and said lands and persons residing thereon shall thereafter be subject to all the rules, regulations, ordinances, taxes and other burdens and benefits of the other persons or property included within the City of Papillion, Nebraska.

Section 2. Effective Date. This ordinance shall be in full force and effect fifteen (15) days after its passage. The city clerk is directed to effectuate the publishing of this Ordinance for at least one (1) week in a newspaper published within the City of Papillion, which publication must take place within fifteen days of the passage of the ordinance by the city council.
