THIS ASSIGNMENT AND ASSUMPTION OF DECLARANT RIGHTS ("Assignment") is made and entered into effective this ___ day of January, 2020, by and between Legacy Homes Omaha, LLC, a Nebraska limited liability company ("Assignor"), and Highlands Ridge Homeowners Association, a Nebraska nonprofit corporation ("Assignee").

WHEREAS, the Lots (defined herein) are subject to the terms of that certain Declaration of Covenants, Conditions, Restrictions and Easements of Highlands Ridge, a Subdivision in Sarpy County Nebraska recorded with the Sarpy County, Nebraska Register of Deeds on February 27, 2014 as Instrument No. 2014-04045 (the "CC&Rs");

WHEREAS, Assignor, as successor in interest to Oakwood Homes of Nebraska, a Delaware limited liability company, is the Declarant under the CC&Rs;

WHEREAS, concurrent herewith, and pursuant to Paragraph 4 of Article IV of the CCR&Rs, Assignor desires to convey to Assignee the rights of Assignor as Declarant under the CC&Rs and Assignee desires to assume such rights.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. Assignment. Assignor as of the date hereof, does hereby assign, transfer, convey and deliver to Assignee, Assignor's rights as Declarant under the CC&Rs (collectively, the "Assigned Rights").
- 2. **Assumption.** Assignee hereby accepts Assignor's assignment of the Assigned Rights and by such assignment shall be deemed to be the Declarant under the CC&Rs.
- 3. Successors and Assigns. This Assignment shall inure to the benefit of, and be binding upon, the respective legal representatives, successors and assigns of the parties hereto.
