Outlots B, C and D, all in Hillcrest CC Addition, Lincoln, Lancaster County, Nebraska;

Lots 1-26, Block 1, Lots 1-6, Block 2, Lots 1-12, Block 3, Lots 1-18, Block 4 and Lots 1-8, Block 5 and Outlots A, B and C, all in Hillcrest CC 1st Addition, Lincoln, Lancaster County, Nebraska; and
