- WHEREAS, petition representing owners of more than 75 percent of the property abutting on alley between 48th Avenue and 49th Street from "W" Street to the South line of Lots 177 and 194, Homestead Addition, located in Northeast Quarter (%), Section 7-14-13 has been filed with the City of Omaha; and,
- WHEREAS, said property owners have in and by said petition waived any and all damages that may be occasioned by said vacation.

 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That alley between 48th Avenue and 49th Street from "W" Street to the South line of Lots 177 and 194, Homestead Addition, is abutted by Lots 171 through 177, inclusive, and Lots 194 through 200, inclusive, all in Homestead Addition located in Northeast Quarter (%), Section 7-14-13

in the City of Omaha, be and hereby is, vacated; the vacating of the property herein described, and the reversion thereof, pursuant to applicable law, shall be subject to the conditions and limitations that there is reserved to the City of Omaha the right to maintain, operate, repair, and renew sewers now existing therein and in the future to construct, maintain, repair and renew additional or other setters; also the right to authorize the Matropalatan Utilities District of the City of O.aha or any other indice utility to construct, maintain, repair or renew and o, rate new emisting or hereafter installed water mains, the line, conduits and other similar services or equipment above, on and below the surface of the ground for the purpose of serving the general public or abutting property; and the right so reserved shall also include such lateral connections or branch lines as may be ordered, desired or permitted by the City and to enter upon the premises to accomplish the above purpose at any and all times. All vegetation upon the premises, including but not limited to, trees, bushes, and cross, and all structures upon the premises, including but not limited to, buildings, walls, iences, driven and walks, ray be desaged or resoved as necessary in the energies of the rillts bergin reserved without compensation to my per en.
