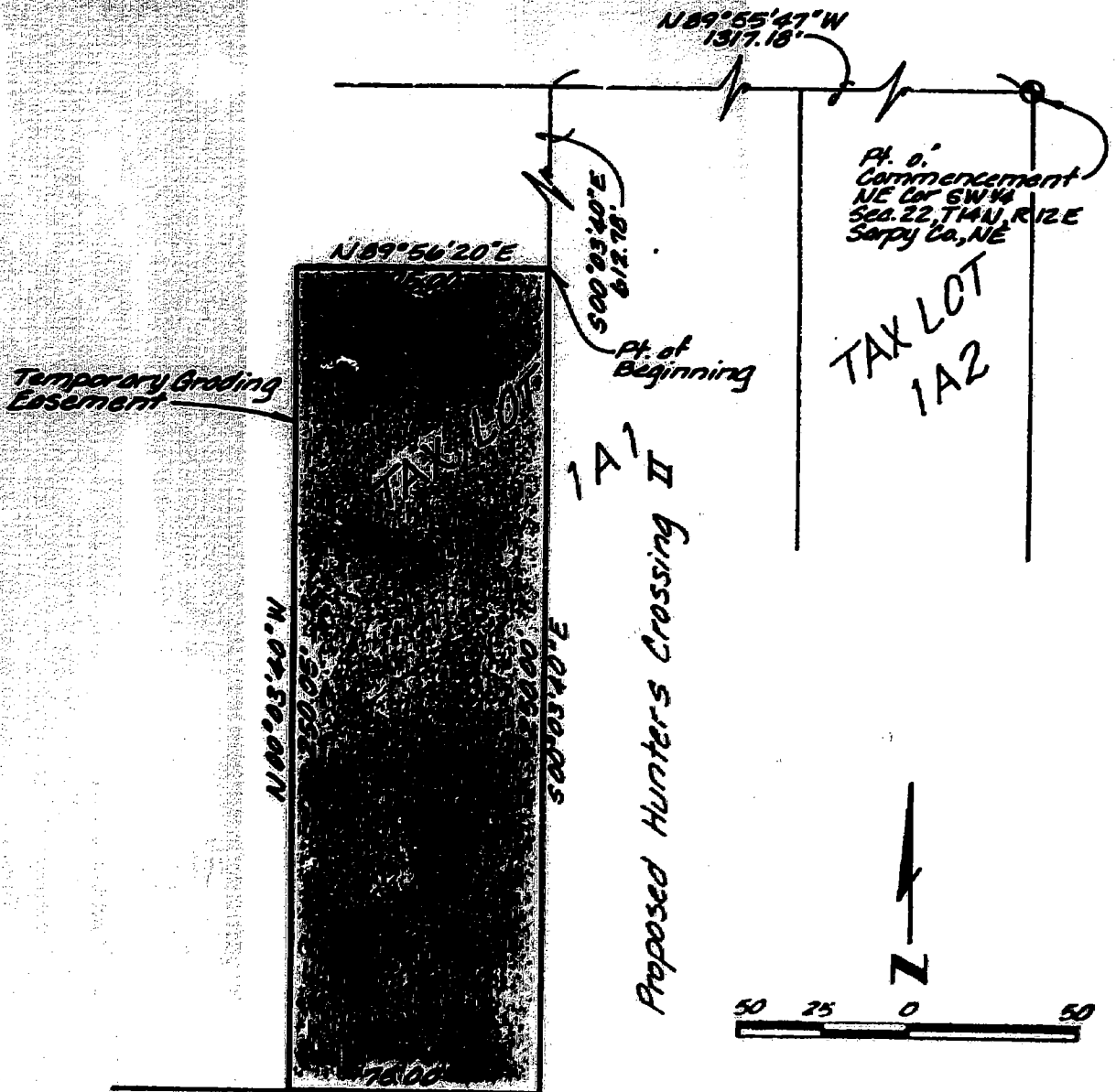
Thence South 00°03'40" East for 612.78 feet to the TRUE POINT OF BEGINNING;
