EIGHTH AMENDMENT TO THE DECLARATION CONDOMINIUM FOR jLOFTS CONDOMINIUM

THIS AMENDMENT TO THE DECLARATION OF CONDOMINIUM for jLofts Condominium recorded June 9, 2008, as Instrument No. 2008056896 as amended ("Declaration"), is herein referred to as the "Amendment" dated the 26 day of May, 2021.

RECITALS

The Declaration of Condominium for jLofts Condominium was recorded with the Register of Deeds of Douglas County, Nebraska on June 9, 2008 as Instrument No. 2008056896 and was amended by (i) First Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on August 5, 2009 as Instrument No. 2009085704, (ii) Second Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on November 25, 2009 as Instrument No. 2009126763, (iii) Third Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on December 17, 2010, as Instrument No. 2010120694, (iv) Fourth Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on August 14, 2013 as Instrument No. 2013082917, (v) Fifth Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on February 20, 2014 as Instrument No. 2014014932, (vi) Sixth Amendment to Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on February 28, 2014 as Instrument No. 2014015045, and (vii) Seventh Amendment to

Declaration of Condominium recorded with the Register of Deeds of Douglas County, Nebraska on November 17, 2020 as Instrument No. 2020134664 collectively referred to hereafter as the "Declarations".

B. The following described property is subject to the Declarations (the "Property"):

Lots 301, 302, 303, 305, 307-317, 401, 402, 403, 405, 407-417, 501, 503-505, 507-512, 514, 516, 601, 603, 605, 608, 610, 612, 614, 614-b and parking lots 101-112, 114-118, 120-132, and 201-261 of jLofts Condominium, a Condominium regime organized under the laws of the State of Nebraska in the City of Omaha, Douglas County, Nebraska, pursuant to Condominium Declaration filed June 9, 2008 as Instrument No. 2008056896 of the records of Douglas County, Nebraska, and any amendments thereto.

The jLofts Condominium Association, Inc. as Declarant wishes to C. establish a Residential Unit Owner Rental Policy. The purpose of the Residential Unit Owner Rental Policy is to maintain the integrity of jLofts Condominium, promote a community ownership feel, and ensure fair and equitable treatment for ¡Lofts Condominium unit owners who desire to rent their unit. The Residential Unit Owner Rental Policy adopted by jLofts Condominium shall hereafter: (i)Prohibit the use of AirBNB, VRBO, Home Away, or any other substantially similar service to rent a unit, and forbid any agreements for the "corporate rental" of units, defined as renting a furnished or unfurnished unit on a temporary basis to individuals, intern groups, or any corporations as an alternative to a traditional hotel or an extended hotel stay, or any other similar rental agreement for a short-term duration; (ii) Require a minimum initial term of no less than six (6) months for the rental of any unit; (iii) Restrict the total number of units being rented at any time to no more than thirty (30) percent of the residential units; (iv) Require any proposed rental agreement or lease of a unit to be approved by jLofts Condominium Board before becoming effective; (v) Require that the standard Nebraska Lease form, as provided by the ¡Lofts Condominium Board, be the only permissible document to use when entering into a lease agreement for any unit; and (vi) Enforce all other terms and conditions of the ¡Lofts Condominium Residential Unit Owner Rental Policy & Procedures as established by the Board of Directors.

D. Unit owners representing no less than Sixty-seven Percent (67%) of the votes of all voting members by percentage ownership in the common elements of iLofts Condominium desire to further amend the Declarations as provided herein.

AMENDMENT

For the reasons stated above, Declarant hereby amends the Declarations as follows and all of such amendments shall supersede any inconsistent provisions in the Declarations.

<u>Effective Date of Amendment.</u> This Amendment shall become effective as of the date of the filing of this instrument with the Douglas County Register of Deeds.

Creation of a Residential Unit Owner Rental Policy. Declarant hereby establishes a Residential Unit Owner Rental Policy. Accordingly, all terms and conditions of the jLofts Condominium Residential Unit Owner Rental Policy & Procedures as established by the Board of Directors must be strictly adhered to. Use of AirBNB, VRBO, Home Away, or any other substantially similar service to rent a unit is strictly prohibited, as are any agreements for the "corporate rental" of a unit, or any other similar rental agreement for a short-term duration. No residential unit may be leased for an initial term of less than six (6) months. At no time can more than thirty (30) percent of residential units be occupied by a nonowner, and any proposed rental agreement or lease must be approved by the jLofts Condominium Board before becoming effective.

<u>Enforcement.</u> The Board of Directors of jLofts Condominium Association, Inc. may enforce compliance of this Amendment at law or in equity. Without limitation, the Board of Directors of jLofts Condominium Association, Inc. may enforce compliance by injunctive relief and by imposing reasonable fines. If fines are imposed, they may be treated as assessments and enforced the same as assessments under the Declarations.

CERTIFICATION

The undersigned President of the Board of Directors of jLofts Condominium Association, Inc. hereby certifies that this Eighth Amendment was approved in compliance with the Declarations at a special meeting called for that purpose on M_{3rch} , 2021.

Except as modified herein, all other terms and conditions of the Declarations shall remain in full force and effect.
