COUNCIL MEMBER WOLFF INTRODUCED THE FOLLOWING ORDINANCE

AN ORDINANCE VACATING A PORTION OF THE RIGHT-OF-WAY FOR VARIOUS STREETS IN THE CITY OF BLAIR, WASHINGTON COUNTY, NEBRASKA, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA, AS FOLLOWS:

SECTION 1. That various streets located in the City of Blair, Washington County, Nebraska, have excess right-of-way that is not necessary for the needs of the City of Blair (See Exhibit A attached hereto and incorporated herein by reference) as a result the excess right-of-way is hereby vacated and the ownership of the same, pursuant to Neb. Rev. Stat. 16-611, shall revert to the owners of the adjacent real estate, on each side of said streets. However, the City of Blair shall retain a utility easement over the vacated areas in order to construct, repair and maintain any and all utilities including but not limited to water, storm sewer, sanitary sewer, electric, natural gas, telephone, cable television, etc.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and following the passage and publication hereof as required by law.

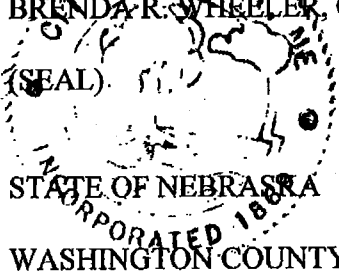

**EXHIBIT "A"**

- 1) Ten feet (10') from the north side of the right-of-way edge and ten feet (10') from the south side of the right-of-way edge of the following streets:
  - a) Jackson Street, from 10<sup>th</sup> Street to 16<sup>th</sup> Street, except for the previous vacation allowed for the property known as N 70' Lots 1 and 2, Block 89 and 15' of vacated Jackson Street, Blair City, Washington County, Nebraska (551 N. 10<sup>th</sup> Street).
  - b) Park Street, from 10<sup>th</sup> Street to 24<sup>th</sup> Street
  - c) Nebraska Street, from 10<sup>th</sup> Street to Hansen Drive
  - d) Lincoln Street, from 19<sup>th</sup> Street to 22<sup>nd</sup> Street
  - e) Grant Street, from 10<sup>th</sup> Street to 22<sup>nd</sup> Street
  - f) Colfax Street, from 10<sup>th</sup> Street to 20<sup>th</sup> Street
  - g) South Street, from 10<sup>th</sup> Street to 25<sup>th</sup> Street
- 2) The entire fifty feet (50') of Fairview Drive ROW from 14<sup>th</sup> Street to 14<sup>th</sup> Avenue. Half of the ROW will go to each adjacent property owner.
- 3) A permanent utility easement will be maintained on all vacated land, including but not limited to water, sanitary sewer, storm sewer, electrical, natural gas, and telephone.
