ORDINANCE NO. 1526

AN ORDINANCE TO ANNEX CERTAIN REAL ESTATE TO THE CITY OF PAPILLION, NEBRASKA, AND TO PROVIDE FOR AN EFFECTIVE DATE THEREOF.

BE IT ORDAINED by the Mayor and City Council of the City of Papillion, Nebraska, as follows:

T14N, R12E; thence easterly along the south line of the west 1/2 of the NW 1/4 Section 33, T14N, R12E to the southeast corner of the west 1/2 of the NW 1/4 Section 33, T14N, R12E; thence northerly along the east line of the west 1/2 of the NW 1/4, Section 33, T14N, R12E to the southerly right-of-way line of State Highway 370; thence easterly along the southerly right-of-way line of State Highway 370 to 96 Street; thence continuing easterly across 96th Street to a point on the southerly right-of-way line of State Highway 370; thence continuing easterly along the southerly rightof-way line of State Highway 370 to 90th Street thence continuing easterly across 90th Street to a point on the southerly right-of-way of State Highway 370; thence continuing easterly along the southerly right-of-way line of State Highway 370 to Washington Street; thence continuing easterly across Washington Street to a point on the southerly right-of-way of Highway 370; thence continuing easterly to a point on the southerly right-of-way line of Highway 370 where the existing City limits cross Highway 370: thence northerly along the existing City limits across Highway 370 to a point on the northerly right-of-way line of Highway 370;

thence westerly along the northerly right-of-way line of Highway 370 to Washington Street; thence continuing westerly across Washington Street to a point on the northerly right-of-way line of Highway 370; thence continuing westerly on the northerly right-of-way line of Highway 370 to the point of beginning and excepting there from Tax Lot 7 in the west 1/2 of the NW 1/4, Section 33, T14N, R12E.

Together with an area described as follows:

Lincoln Street to the existing City limits; thence southerly along the existing City limits to the northeast corner of Lot 3 Overland Hills V, a subdivision surveyed, platted, and recorded in Sarpy County Nebraska; thence southerly along the easterly lot line of Lots 3, 2 & 1 of said Overland Hills V to the northerly right-of-way of Rawhide Road; thence continuing southerly across Rawhide Road and along the easterly lot lines of Lots 137,130 and 129 of said Overland Hills V to the existing City limits; thence continuing southerly along the existing City limits to the northerly right-of-way line of Nebraska State Highway 370; thence northwesterly along the northerly right-of-way line of Nebraska State Highway 370 to the easterly right-of-way line of 96th Street; thence continuing northwesterly along the northerly right-of-way line of Nebraska State Highway 370 across 96th Street to the point of beginning.

<u>Section 2.</u> The City Council has received and considered the recommendation of the Papillion Planning Commission.

<u>Section 3.</u> Effective Date. The city clerk is directed to effectuate the publishing of this Ordinance for at least one (I) week in a newspaper published within the City of Papillion, which publication must take place within fifteen days of the passage of the ordinance by the city council.
