ORDINANCE NO. 557

ORDINANCE DECLARING THE NECESSITY, EXPEDIENCE AND
PROPERTY OF VACATING THE ALLEY IN BLOCK 53 IN THE CITY OF
MAYNARD, SENECA COUNTY, NEBRASKA, REPEALING ALL ORDINANCES
AND LAWS IN CONFLICT HEREWITH AND
DECLARING EFFECTIVE DATE.

ENACTED BY THE MAYOR AND COUNCIL OF THE CITY OF
MAYNARD, NEBRASKA

SECTION 1. - IT IS HEREBY NECESSARY, EXPEDIENT AND
PROPER TO VACATE THE ALLEY IN BLOCK 53 AND THE SAME BE AND
HEREBY IS VACATED.

SECTION 2. ALL ORDINANCES AND PARTS OF ORDINANCES IN
CONFLICT HEREWITH ARE HEREBY REPEALED.

SECTION 3. THIS ORDINANCE SHALL BECOME EFFECTIVE AFTER
ITS PASSAGE, APPROVAL AND PUBLICATION ACCORDING TO LAW.

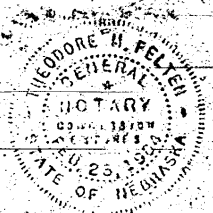

ORDINANCE NO. 557

AN ORDINANCE DECLARING THE NECESSITY, EXPEDIENCE AND PROPRIETY OF VACATING THE ALLEY IN BLOCK 53 IN THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA; REPEALING ALL ORDINANCES AND ALL PARTS OF ORDINANCES IN CONFLICT HERewith AND DESIGNATING EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELLEVUE, NEBRASKA:

Section 1.
It is hereby necessary, expedient and proper to vacate the alley in Block 53 and the same be and hereby is vacated.

Section 2.
All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 3.
This ordinance shall become effective after its passage, approval and publication according to law.
