## RIGHT-OF-WAY DEED

THIS INDENTURE, made in Lincoln, Lancaster County, Nebraska, on November 7, 1949, by YANKEE HILL BRICK MANUFACTURING COMPANY, a corporation, having its principal place of business in Lancaster County, Nebraska, (herein called grantor), and C.W. SWINGLE & COMPANY, LTD., a partnership, having its principal place of business in Lancaster County, Nebraska, (herein called grantee).

WITNESSETH: Grantor in consideration of One Dollar (\$1.00) paid to it by grantee, receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey to grantee, a right-of-way for an underground pipe line in and through the following described property in Lancaster County, Nebraska:

> Lot Nine (9), an irregular tract located in the Northeast Quarter (NE\*) of the Southwest Quarter (SW\*) of Section Twenty-two (22) Township Ten (10) North, Range Six (6) East of the Sixth P.M., and

Lot One Hundred Fifteen (115), an irregular tract located in the Southeast Quarter (SE#) of the Southwest Quarter (SW#) of Section Twenty-two (22), Township Ten (10) North, Range Six (6) East of the Sixth P. M.

Grantor hereby covenants with the grantee that the grantee shall have the right to construct, reconstruct and maintain an underground pipe line along said right-of-way, and do all things reasonable and necessary to the construction, reconstruction and maintenance thereof; and that the grantee, by any of its agents and employees, shall have the right to enter upon the premises at any time for purposes of constructing, reconstructing or maintaining the pipe line.

Grantor hereby covenants with the grantee that the grantee will replace soil moved in laying the pipe line in such a way that after settlement it shall be level, and that grantee shall pay to grantor for any and all damages done to grantors property by the construction of said pipe line and agrees to save grantor harmless from any and all liability to any and all persons caused by either the construction, reconstruction or repair of said pipe line.

Grantee agrees to permit grantor to use gas from said pipe line at any time in the future that grantor might desire to do so, providing that said pipe line has sufficient capacity to supply gas for such use.
