EASMENT AND RIGHT OF WAY

For value received the undersigned, hereinafter called grantors, hereby grant and convey to the City of Blair, Nebraska; hereinafter called the City, its successors and assigns, a perpetual easement to construct, operate and maintain an electric transmission line, together with necessary poles, wires, guys and other fixtures and appliances over, upon, along and above the property herein described located in Washington County, Nebraska:

A STRIP OF LAND 10.0 FEET IN WIDTH, THE NORTH LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT THE $\frac{1}{4}$ CORNER NORTH OF THE SW CORNER OF SECTION 2, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE 6th P.M., WASHINGTON COUNTY, NEBRASKA AND ASSUMING THE $\frac{1}{4}$ LINE NORTH OF THE SOUTH LINE OF SECTION 2 TO BEAR S $89^{\circ}19'48''$ E; THENCE S $89^{\circ}19'48''$ E ALONG SAID $\frac{1}{4}$ LINE A DISTANCE OF 949.02 FEET TO THE POINT OF TERMINATION, SAID POINT BEING ON THE SOUTHWESTERLY R.O.W. OF U.S. HIGHWAY NO. 73.

AND ALSO

A STRIP OF LAND 10.0 FEET IN WIDTH, THE NORTH LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT THE $\frac{1}{4}$ CORNER NORTH OF THE SE CORNER OF SECTION 3, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE 6th P.M., WASHINGTON COUNTY, NEBRASKA AND ASSUMING THE $\frac{1}{4}$ LINE NORTH OF THE SOUTH LINE OF SAID SECTION 3 TO BEAR N $89^{\circ}18'41''$ W; THENCE N $89^{\circ}18'41''$ W ALONG SAID $\frac{1}{4}$ LINE A DISTANCE OF 269.63 FEET TO THE POINT OF TERMINATION, SAID POINT BEING ON THE NORTH EASTERLY R.O.W. OF THE COUNTY ROAD ("8th Avenue").

The grantors hereby grant to said City, its successors and assigns the right, privilege and authority to enter upon and pass over said property and the property of the grantor adjacent thereto for the purpose of constructing, repairing, operating and maintaining said lines and equipment upon the property above described.

The grantors hereby grant to said City, its successors and assigns, the permanent right, privilege and authority to cut down trees over or within five (5) feet of the City's lines and to cut down or trim any trees or limbs of trees over or on either side thereof as would be a hazard to said lines in breaking off and falling over or against said lines.

The City shall at all times exercise all due care and diligence to avoid any injury or damage to the crops, livestock and other personal property of the grantors and the City agrees to indemnify




