AN ORDINANCE ANNEXING THREE TRACTS OF LAND CONTIGUOUS TO THE CITY OF BLAIR, NEBREASKA, MORE PARTICULARLY DESCRIBED HEREINBELOW; AND EXTENDING THE LIMITS OF THE CITY OF BLAIR TO INCLUDE SAID ANNEXED TERRITORY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA:

SECTION 1. WHEREAS, the following tracts of land,

A DISTANCE OF 66.0 FEET TO THE SE CORNER OF LOT 9 IN GREENBRAIR ADDITION TO THE CITY OF BLAIR; THENCE NORTHERLY ALONG THE EASTERLY LINE OF SAID GREENBRIAR ADDITION AND THE EASTERLY LINE OF SAID BECK'S ADDITION TO THE POINT OF BEGINNING, LYING IN THE NW1 NE1 AND THE NE1 NW1 OF SECTION 12, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE 6TH P.M., AND THE SW1 AND THE SE1 SW2 OF SECTION 1, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE 6TH P.M., ALL IN WASH INGTON COUNTY, NEBRASKA.

BEGINNING AT THE NE CORNER OF LOT 1, BLOCK 1, HOSPITAL PARK ADDITION SAID POINT OF BEGINNING BEING ON THE SOUTHWESTERLY R.O.W. OF U.S. HIGHWAY NO. 73; THENCE NORTHWESTERLY ALONG SAID SOUTHWESTERLY R.O.W. TO A POINT ON THE 1 LINE NORTH OF THE SOUTH LINE OF SECTION 2, T 18 N, R 11 E; THENCE EASTERLY ALONG SAID 1 1 LINE TO A POINT ON THE NORTHEASTERLY R.O.W. OF SAID HIGHWAY NO. 73; THENCE SOUTHEASTERLY ALONG SAID NORTH-EASTERLY R.O.W. TO A POINT 80.0 FEET DISTANT FROM THE POINT OF BE-GINNING AS MEASURED PERFENDICULAR TO SAID NORTHEASTERLY R.O.W.; THEN E SCUTHWESTERLY A DISTANCE OF 80.0 FEET TO THE POINT OF BEGINNING, LYING IN THE ST SWT AND THE SWT SET OF SECTION 2, TOWNSHIP 18 NORTH, RANGE 11 EAST, AND IN THE NWT NET OF SECTION 11, TOWNSHIP 18 NORTH, RANGE 11 EAST, ALL IN WASHINGTON COUNTY, NEBRASKA.

are contiguous to the City of Blair and are urban or suburban in character and the Mayor and City Council herewith deem it necessary and advisable to annex said territory to the City of Blair.

SECTION 2. That a majority of the City Council of the City of Blair voted in favor of said annexation.

SECTION 3. That the tracts of land described herein be and the same hereby are annexed to the City of Blair, Nebraska.

SECTION 4. The limits of the City of Blair, Nebraska, are hereby extended to include this said territory.

SECTION 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 6. This ordinance shall be in force and take full effect from and after its passage, approval and publication as provided by law.
