Grantee shall be solely responsible for maintenance of all sever mains and facilities within the easementway and for prompt restoration of the ground surface and all landscaping thereon as soon as

Grantee hereby agrees to hold and save the Grantor harmless from any and all damage arising from Grantee's use of the easement granted herein and agrees to pay any damage or damages which may arise to the property of any party as a result of Grantee's use, occupation and possession of the rights herein granted. Grantor shall have the right at any time to make connections to the sanitary sewer constructed upon the premises described herein and may use said sewer, but at no expense to Grantor. The provisions hereof shall inure to the benefit of and bind the successors and assigns of the respective parties hereto, and all covenants shall apply to and run with the land.
