KNOW ALL MEN BY THESE PRESENTS:

That Hastings College Bellevue, Nebraska of the County of Sarpy and State of Nebraska, for and in consideration of the sum of One Dollar (\$1.00), receipt of which consideration is hereby acknowledged, do hereby GRANT, REMISE, SELL and CONVEY unto Peoples Natural Gas Company, a corporation, its successors and assigns, the RIGHT, PRIVILEGE and EASEMENT to construct, maintain and operate a natural gas pipe line for local service, and appurtenances thereto, over and through the following described lands situated in Sarpy County, State of Nebraska:

Commencing at a point 222.7' south of North Quarter Corner Section 36, Township 14, North Range 13, East of the 6th P.M. on North and South Center Line of said Section; thence East 468.6' to the Mission Reserve Line at a point 237.9' South of the North Line of said Section 36; thence South 2699.1' to the Stone at the angle in the Mission Reserve Line; thence West on the line of the Mission Reserve 583.8'; thence North and parallel with the West Line of the Mission Reserve 1928.5'; thence West parallel with the North line of said Section 36.643'; thence North and parallel with the West Line of Mission Reserve 1011.7' to North Line of said Section 36, thence East along North Line of said Section 758.2' to North Quarter Corner of said Section 36, thence South 222.7' to the place of beginning, except the right of way of The Omaha and Southern Interurban Railway,
