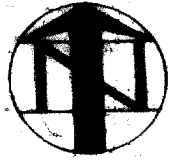
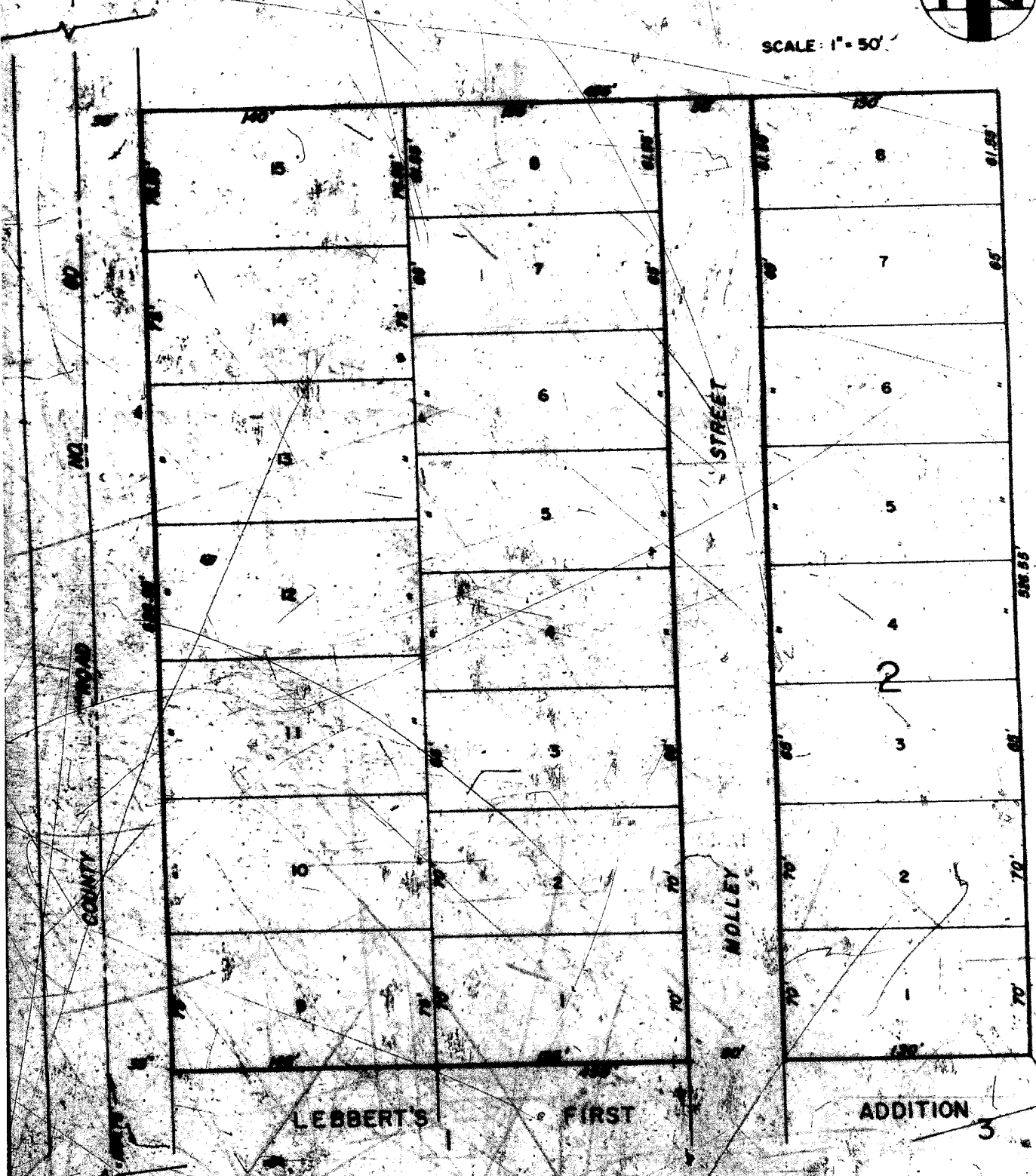

I, Gerald E. Richey, a Surveyor of Nebra, Douglas County, Nebraska hereby certify as follows:  
That I have carefully surveyed and staked the lots of Lebberts Second Addition to the Village of  
Bennington, Douglas County, Nebraska, as shown on the plat attached and that the description of the  
said lots and of this Addition is as follows:

A tract of land in the NE 1/4 of Section 11, T10N, R11E of the 4th P.M., Douglas County, Nebraska,  
more particularly described as follows: Commencing at a point 1694.75 feet north and 33 feet east  
of the southeast corner of said section 11; thence east along the north line of Lebberts First  
Addition to the Village of Bennington, a distance of 431.0 feet; thence north parallel to the
