RELEASE OF EASEMENT

This indenture made this 17th day of 10th day of 2003 by the State of Nebraska, Department of Roads, hereinafter referred to as the Department:

WITNESSETH: That the Department in consideration of the sum of Six Thousand One Hundred Forty and no/100 –(\$6,140.00)--, does hereby release a permanent easement for Highway Construction and Maintenance purposes which was acquired from Utopia, LLC on the 10th day of October, 2000 and recorded in Book 1374, Pages 333-334 of the Douglas County Deed Records, and also, in consideration of the sum of One and no/100 –(\$1.00)--, does hereby release a permanent easement for Cut and Fill purposes which was acquired from Children's Memorial Hospital Foundation on the 19th day of November, 1991 and recorded in Book 997, Pages 342-343 of the Douglas County Deed Records.

The easement being released by this instrument is described as follows:

A tract of land located in the Northwest Quarter of Section 33, Township 15 North, Range 11 East of the Sixth Principal Meridian, Douglas County, Nebraska, described as follows:

Referring to the Northeast corner of said Quarter Section; thence southerly a distance of 56.52 feet along the east line of said Quarter Section; thence westerly deflecting 087 degrees, 53 minutes, 12 seconds right, a distance of 505.42 feet to the point of beginning; thence westerly deflecting 000 degrees, 04 minutes, 43 seconds right, a distance of 585.13 feet; thence westerly deflecting 007 degrees, 55 minutes, 03 seconds left, a distance of 166.23 feet; thence westerly deflecting 021 degrees, 42 minutes, 18 seconds right, a distance of 335.91 feet; thence easterly deflecting 167 degrees, 24 minutes, 21 seconds right, a distance of 877.22 feet; thence easterly deflecting 009 degrees, 51 minutes, 55 seconds right, a distance of 202.74 feet to the point of beginning, containing 42,283.12 square feet, more or less.
