KNOW ALL MEN BY THESE PRESENTS:

THAT CHILDRENS MEMORIAL HOSPITAL FOUNDATION

organized and existing under and by virtue of the laws of the State of Nebraska hereinafter known as the Grantor, for and in consideration of the sum of ONE AND NO/100--(\$1.00)--AND OTHER VALUABLE for and in CONSIDERATION -- DOLLARS in hand paid does hereby grant and convey unto THE STATE OF NEBRASKA, DEPARTMENT OF ROADS, and to its successors and assigns the following described permanent easement for CUT AND FILL PURPOSES and the subsequent maintenance of same, situated in DOUGLAS County, and State of Nebraska, to-wit;

TRACT OF LAND FOR CUT AND FILL PURPOSES LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 15 NORTH, RANGE 11 EAST OF THE SIXTH PRINCIPAL MERIDIAN DOUGLAS COUNTY, NEBRASKA, DESCRIBED AS FOLLOWS:

REFERRING TO THE NORTHEAST CORNER OF SAID QUARTER SECTION; THENCE SOUTHERLY A DISTANCE OF 56.52 FEET ALONG THE EAST LINE OF SAID QUARTER SECTION; THENCE WESTERLY DEFLECTING 087 DEGREES, 53 MINUTES, 12 SECONDS RIGHT, A DISTANCE OF 505.42 FEET TO THE POINT OF BEGINNING; THENCE WESTERLY DEFLECTING OOD DEGREES, 05 MINUTES, 21 SECONDS LEFT, A DISTANCE OF 800.39 FEET; THENCE WESTERLY DEFLECTING 016 DEGREES, 25 MINUTES, 53 SECONDS RIGHT, A DISTANCE OF 206.71 FEET TO A POINT ON THE SOUTHERLY EXISTING HIGHWAY RIGHT OF WAY LINE; THENCE EASTERLY DEFLECTING 164 DEGREES, 55 MINUTES, 46 SECONDS RIGHT, A DISTANCE OF 800.02 FEET ALONG SAID RIGHT OF WAY LINE; THENCE EASTERLY DEFLECTING 009 DEGREES, 51 MINUTES, 55 SECONDS RIGHT, A DISTANCE OF 202.74 FEET TO THE POINT OF BEGINNING CONTAINING 0.86 ACRES, MORE OR LESS.

The abandonment of said permanent easement for the purposes described herein shall render this conveyance void and cause said permanent easement to revert to said Grantor and to its successors and assigns.
