, OBDINARCE NO. 563

An Ordinance to release an Besement over and across certain lands in Lincoln Park Addition to the City of Elair, Nebraska:

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BLAIR, NEBPASKA:

Sec. 1. WHEREAS, the owners of the large and lots in Lincoln Park Addition to the City of Plair, Nebraska have filed

with the Register of Deeds of Washington County, Nebraska, a Vacation of Lincoln Pork Addition to the City of Blair, Nebraska, and it appearing that the lots and lands in said Addition are now resubdivided and made Lincoln Addition to the City of Elair, Nebraska and the City boving no use for an easement over and across the following land, to-wit:

The South 12 ft. of Lote 1, 2, 3, 4, 5 and 6, Lincoln Park Addition to the City of Elair, Nebraska and the East 12 ft. of Lots 7, 8, 9 and 10, Lincoln Park Addition to the City of Nebraska and the Blair, Nebraska.

We deem it advantageous and best for the interests of the City to release said Easement, Now Therefore

Sec. 2. The Easement as above described to the City of Blair, Nebraska and shall be and hereby is wholly and entirely vacated and released and shall no longer be in existence and shall revert to the owners of lots or lands over and across which said Easement runs, the same in proportion to the respective ownership of such lots or grounds.

Sec. 3. The City Clerk shall and hereby is authorized and directed to file a certified copy of this Ordinance with the Register of Deeds of Washington County, Nebraska.

Sec. 4. All Ordinances and parts of Ordinances is conflict heresity shall and the same here by are repealed.

Sec. 5. This Ordinande shall be in force and effect from and after its passage, approval and publication as required by law.

This indenture made this 2nd day of May, 1940 between Simon Korshoj and Virginia Korshoj, his wife and Karl Christensen and Merle Christensen, his wife, of Elair, Nebraska of the first part, and The City of Blair, Nebraska, The Flair Telephone Company and The Iowa-Nebraska Light and Fower Company of the second part,

WITNESSETH, Party of the first part in consideration of one dollar and other valuable consideration paid by the parties

of the second part, receipt of which is hereby acknowledged, hereby sells, grants and conveys unto

second parties and their successors and assums forever a right of way onto and over a strip of land 12 ft. wide and 39% 3/10 ft. long, more particularly described as follows, to wit;

Commencing at the Northeast Corner of Lot 12, Lincoln Addition to the City of Flair, Nebraska; Thence South 6 ft. slong the East line of said Lot 12; Thence West to the West line of Lot 7, Lincoln Addition to the City of Flair, Rebraska, along a line 6 ft. South of and parallel with the Worth line of Lots 12, 11, 10, 2, 5 and 7, Lincoln Addition to the City of Flair, Nebraska; Thence West Line of Lots 7, Lincoln Addition to the City of Flair, Nebraska; along the West line of Lots 7 and 6, Lincoln Addition to the City of Flair, Nebraska; Thence East to the East line of Lot 1, Lincoln Addition to the City of Elair, Nebraska; Thence a line 6 ft. North of and parallel with the South line of Lots 6, 2, 4, 3, 2 and 1, of Lot 12, Lincoln Addition to the City of Flair, Nebraska, along Lincoln Addition to the City of Flair, Nebraska; Thence South to the Morthwest Corner Lot 1; Lincoln Addition to the City of Blair, Nebraska, along the East line of said lin Lincoln Addition to the City of Blair, Nebraska, to the place of beginning, all in the City of Elair, Washington County, Nebraska.

Upon which right of way parties of the second part shall have the right to construct and maintain distribution systems for public utilities of any nature, kind or description and to operate cars, trucks, wagons, trailers or any other vehicle therein, and do all other acts necessary in the maintenance and operation of said utilities.

Parties of the first part also hereby sell, grant and convey unto the City of Elair and the Elair Telephone Company, their successors and assigns, the right, privilege and authority to trim any trees or shrubs and to enter upon said real estate for the purpose of trimming any trees or shrubs located in Lincoln Addition to the City of Blair, Nebraska, which may interfare with the maintenance and operation of their lines located within said Lincoln Addition.

Parties of the first part also hereby sell, Frant and convey unto the City of Flair, Nebraska and the Elair Telephone Company, their successors and assigns the right, privilege and authority to cross over any real estate in Lincoln Addition to the City of Elair, Nebraska with service drops leading from their lines to any building located within Lincoln Addition to the City of Elair, Nebraska.
