ORDINANCE NO. 2295

COUNCIL MEMBER HALL INTRODUCED THE FOLLOWING ORDINANCE:

AN ORDINANCE VACATING 15' OF THE RIGHT-OF-WAY ALONG BOTH SIDES OF 23RD STREET BETWEEN WASHINGTON AND LINCOLN STREETS IN THE CITY OF BLAIR, WASHINGTON COUNTY, NEBRASKA, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA, AS FOLLOWS:

SECTION 1. That both sides of 23rd Street between Washington and Lincoln Streets have excess right-of-way that is not necessary for the needs of the City of Blair. As a result, the area consisting of the east fifteen feet (15') of the 23rd Street right-of-way from Washington Street to the southern side of the Lincoln Street right-of-way extending from 23rd Street to 25th Street, and the area consisting of the west fifteen feet (15') of the 23rd Street right-of-way from Washington Street to the northern side of the Lincoln Street right-of-way extending from 23rd Street to 25th Street is hereby vacated and the ownership of the same, pursuant to Neb. Rev. Stat. 16-611, shall revert to the owners of the adjacent real estate. However, the City of Blair shall retain a utility easement over the vacated areas in order to construct, repair and maintain any and all utilities including but not limited to water, storm sewer, sanitary sewer, electric, natural gas, telephone, cable television, etc.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and following the passage and publication hereof as required by law.


