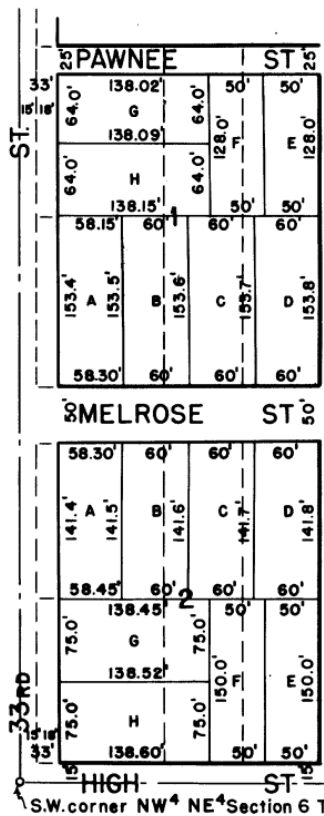


Lincoln, Nebraska

DEDICATION

The foregoing subdivision of Lots 10, 11 and the east 98 feet of Lot 12, Block 2, and also of Lots 10, 11 and the east 98 feet of Lot 12, Block 3, all in the plat of Myrtle Heights Second Addition To College View, Lancaster County, Nebraska, now a part of Lincoln, Nebraska, and the platting of the same, as appears on the annexed plat, as "LINCOLNSITE," Lincoln, Nebraska, is with the free consent and in accordance with the desire of the undersigned sole owners and proprietors.

An easement on the rear two (2) feet of all lots; on the west two (2) feet of Lot F and on the south two (2) feet of Lot H, Block 1; also on the north two (2) feet of Lot G and on the west two (2) feet of Lot F, Block 2, is hereby dedicated to the use of the public for the construction and maintenance of sewers, conduits and pole lines. The street designated as Pawnee Street on the annexed plat is hereby dedicated to the use of the public.

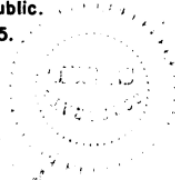

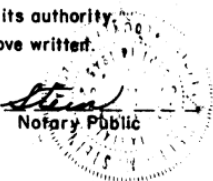
