names this 1st day of June, 1951.

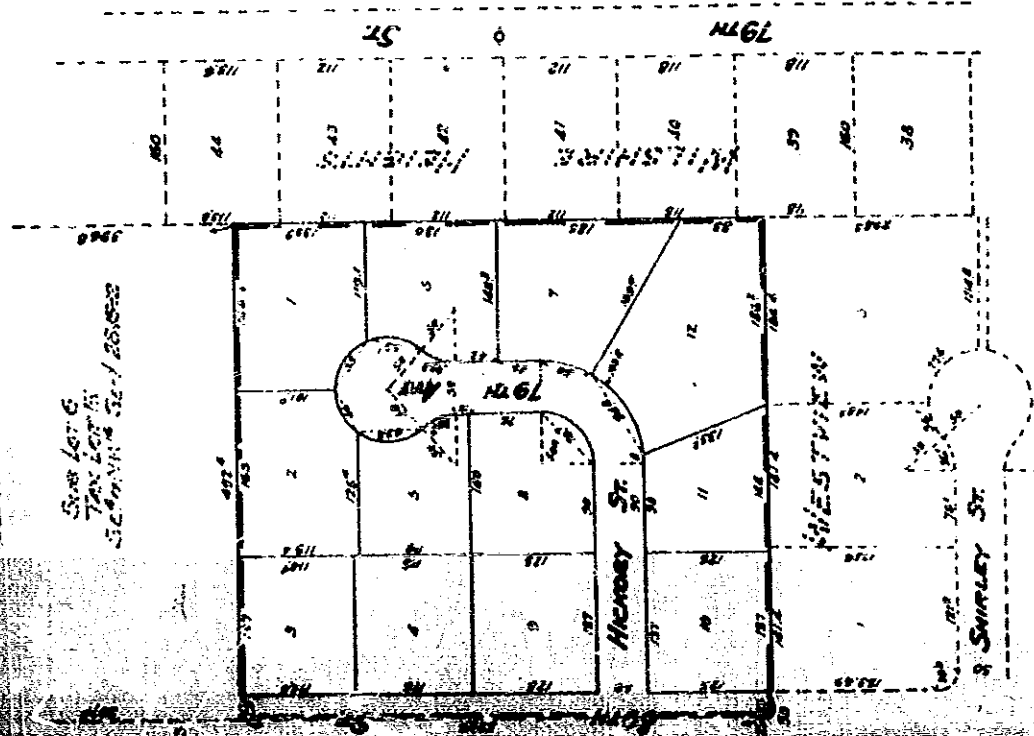
