KNOW ALL MEN BY THESE PRESENTS, that COX COMMUNICATIONS INC. for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of an Alley Vacation Ordinances, over, upon, along, and above the certain real estate located in Douglas County, Nebraska described as follows:

A Vacation Ordinance #27503 where the North 132 feet of the North/South alley between 25<sup>th</sup> Avenue and 26<sup>th</sup> Street and St. Mary's Avenue to Dewey Avenue, all in the City of Omaha, Douglas County, Nebraska was vacated. Together with Vacation Ordinance #24730 being that part of the Alley between 25<sup>th</sup> Avenue and 26<sup>th</sup> Street from a point 123 feet South of the South line of Dewey Avenue was vacated.
