- BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMBHA:

Section 1. All vegetation upon the previous, including but not limited to, treen, bushes, and crops, and all structures upon the premises, including but not limited to, buildings, walls, fences, drives and walks, may be damaged or removed as necessary in the exercise of the rights herein reserved without compensation to any person.
