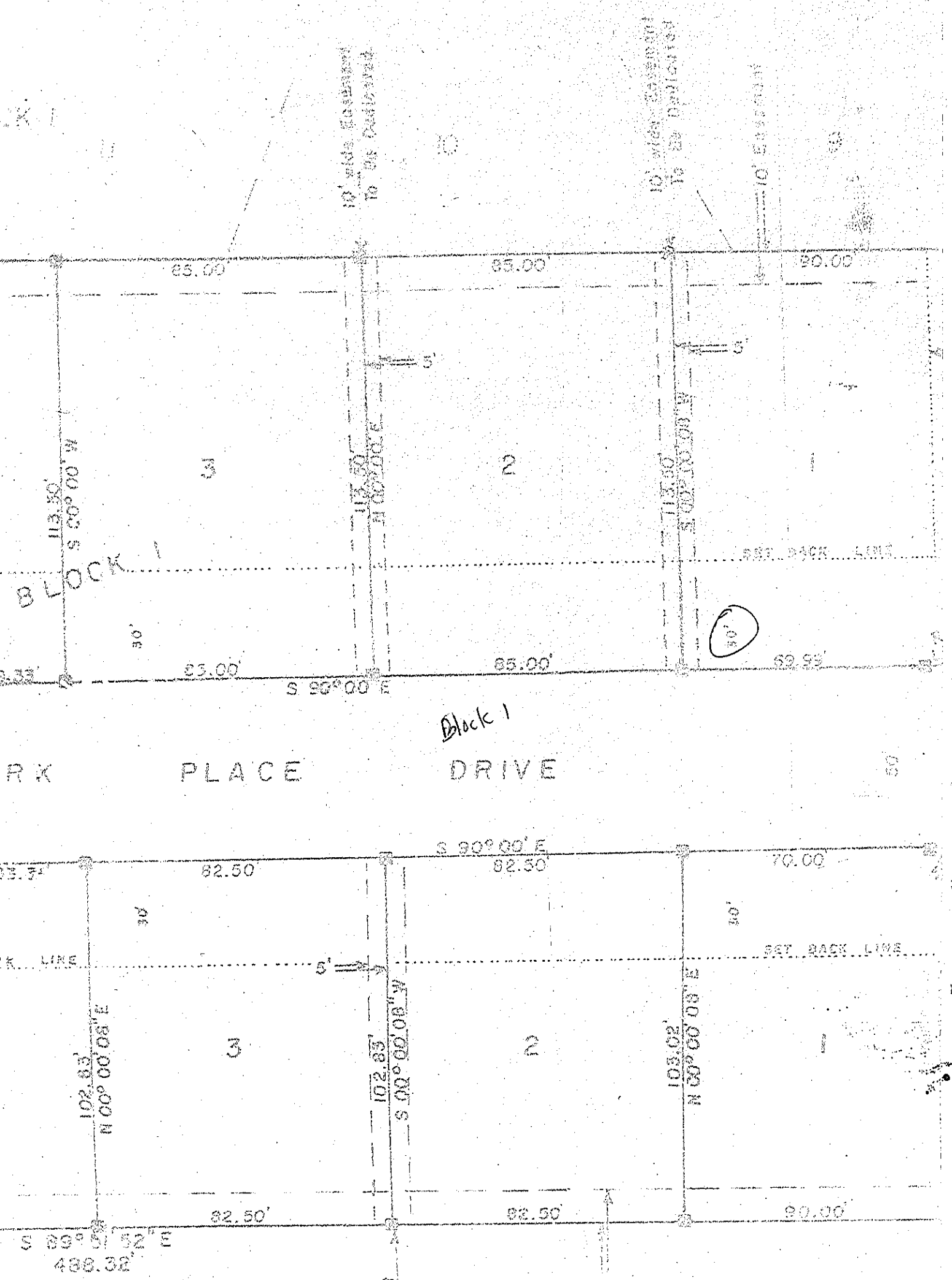


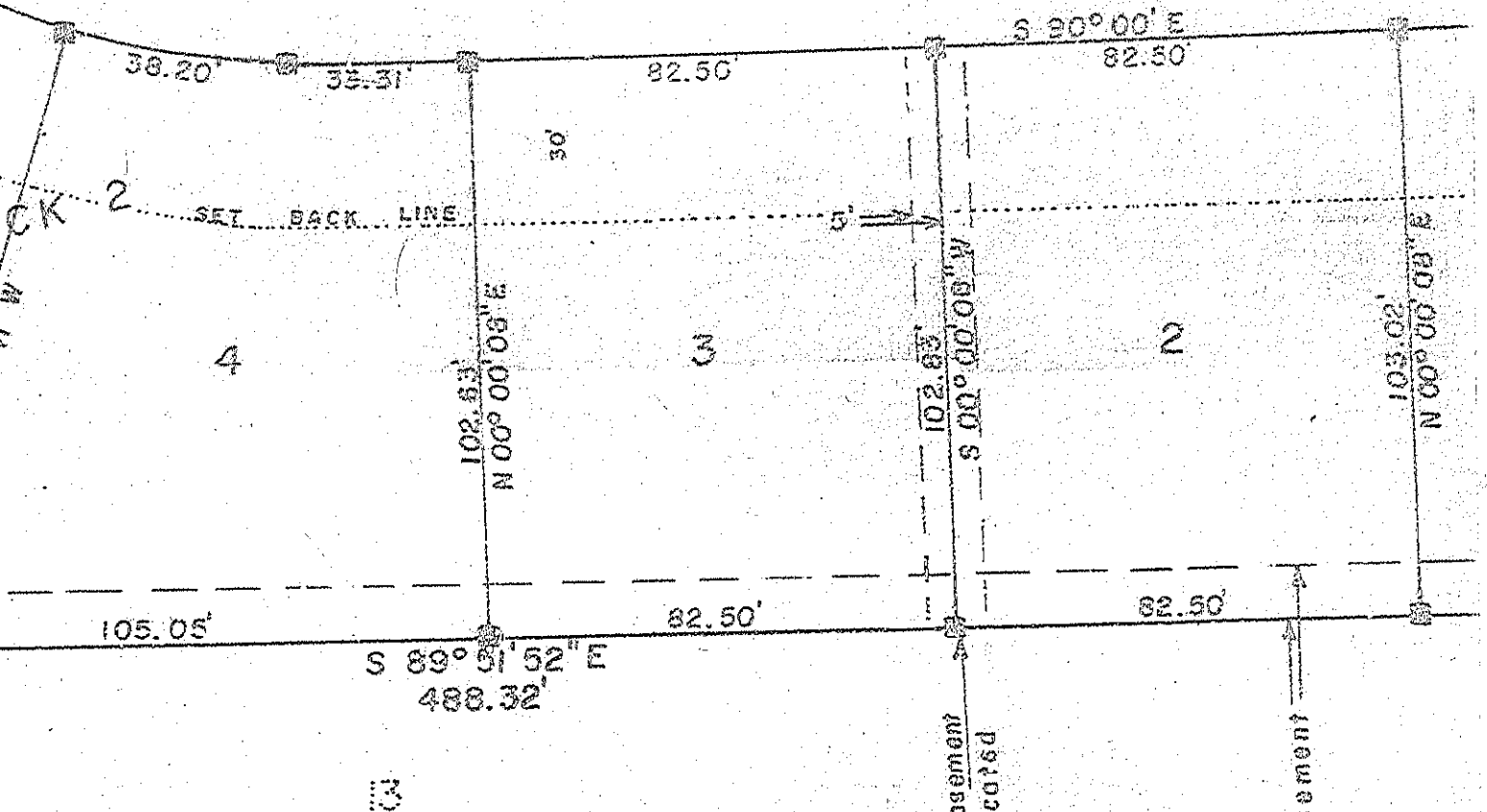
FINAL PLAT OF BLOCK FOURTH ADDITION

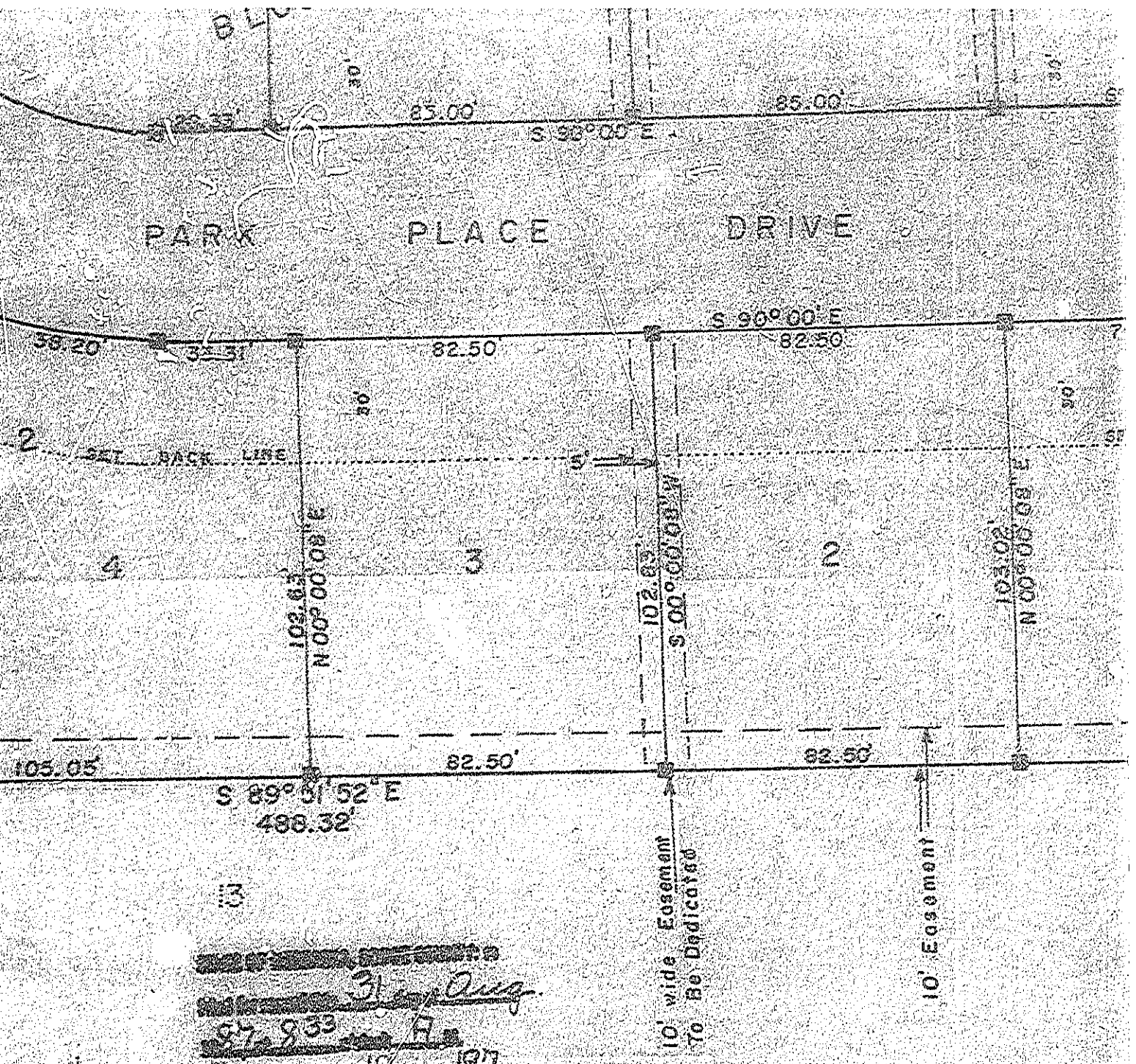
