in Lincoln, Lancaster County, Nebraska

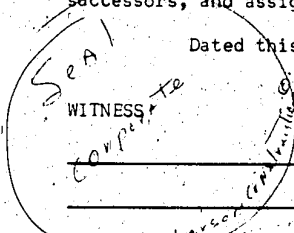
in the City of Lincoln, Lancaster County, Nebraska, do hereby grant and convey to the CITY OF LINCOLN, NEBRASKA, a municipal corporation, its successors, and assigns, the right to construct, reconstruct, perpetually maintain, and operate underground street light circuits, together with the necessary cables, wires, underground conduits, etc., with the right to enter said premises for the purpose of repairing, replacing, operating, and maintaining said underground street light circuits on the said property at about the following location:

Two feet on north side of lot common to lots 3 and 4 Block 6 in Meadow Lane

Fifth Addition, Lincoln, Lancaster County, Nebraska.

This grant shall be binding upon the heirs, executors, administrators, successors, and assigns of the grantors herein.

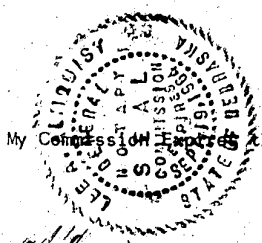
