EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That for One Dollar (\$1.00), in hand paid, receipt of which is hereby acknowledged, T. H. Maenner Co., a Nebraska corporation, does hereby grant to Omaha Public Power District, its successors and assigns, a permanent easement, with rights of ingress and egress thereto, to install, operate, maintain, repair, replace and renew its electric utility facilities over, upon and under the said (10) foot strips of land as shown on the attached Exhibit "A" and which are more particularly described as follows:

The Westerly ten (10) feet, parallel with the rear boundary line, of the rear thirty (30) feet of Lots one (1) through seven (7), Block four (4) and of Lots thirty-three (33) through forty (40), Block two (2) and the ten (10) foot strip of land the center line of which extends across Lot thirty-two (32), Block two (2) from a point on the Southeast boundary line that is approximately thirty (30) feet from the Northeast corner of said lot to a point on the North boundary line that is approximately twenty-eight (28) feet West of the Northeast corner of said lot. All of the aforesaid lots are in Meadowview, an addition, as surveyed, platted and recorded in the South 1/2 of the Southeast 1/4 of Section 19, Township 15 North, Range 12 East of the 6th P.M. in Douglas County, Nebraska.

After electric utilities facilities have been installed in the easement, no trees, buildings or other structures shall be placed in or encroach the easement and no change in grade elevations or excavations shall be made therein but the same may be used for gardening, landscaping or other purposes that do not then or later interfere with the said easement uses.
