## AMENDED AFFIDAVIT OF CORRECTION

To correct the "Millard Park South 2" Subdivision plat recorded in Sarpy County, Nebraska.

The Dedication shall read as follows:

## **DECICATION**

KNOW ALL MEN BY THESE PRESENTS: That We, DODGE LAND CO., a Nebraska Corporation, OWNER, and FIRST NATIONAL BANK OF OMAHA, MORTGAGEE, being the sole OWNER and MORTGAGEE of the land described within the Land Surveyor's Certificate and embraced within this plat, have caused said land to be subdivided into lots and streets to be numbered and named as shown hereon, said subdivision to be hereafter known as MILLARD PARK SOUTH 2 (Lots 330 through 346, inclusive, and Sublots 1 through 6 of Lot 342, Sublots 1 through 24 of Lot 343, Sublots 1 through 4 of Lot 344, Sublots 1 through 10 of Lot 345 and Sublots 1 through 20 of Lot 346) and we do hereby ratify and approve of the disposition of our property as shown on this plat; and we do hereby dedicate to the public the streets as shown on the plat and do hereby grant the easements shown on the plat.
