ORDINANCE NO. 387

AN ORDINANCE TO AMEND ORDINANCE NO. 334 AND TO AMEND ORDINANCE NO. 315 OF THE CITY OF GLENWOOD, IOWA, AND TO EXTEND THE POWERS GRANTED BY CHAPTER 414 OF THE CODE OF IOWA, 1971, TO THE CITY OF GLENWOOD, IOWA, TO THE UNINCORPORATED AREA BEYOND THE LIMITS OF SAID CITY DESCRIBING THE AREA TO BE INCLUDED AND INCREASING THE SIZE OF THE PLANNING AND ZONING COMMISSION AND THE BOARD OF ADJUSTMENT AS PROVIDED BY LAW.

BE IT ORDAINED BY THE CITY OF GLENWOOD, IOWA:

Section 1. That the powers granted to the City of Glenwood, Iowa, under Chapter 414 of the Code of Iowa, 1971, and as exercised by said City under Ordinance No. 334 and the amendments thereto is hereby extended to that part of the following described real estate lying outside the incorporated area of the City of Glenwood, Iowa:

All of Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 23, and 24; the East one-fourth of Section 9; the East one-half of Section 22; and the East Half of the Northwest Quarter of Section 22; the North Half of Section 26; and the North Half of Section 25, all in Township 72 North, Range 43 West of the 5th P.M., Mills County, Iowa.

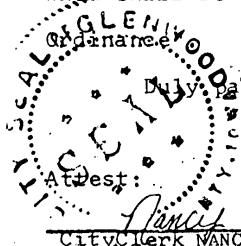
The East three-fourths of the South Half of Section 34; the South three-fourths of Section 35; and the South three-fourths of Section 36, all in Township 73 North, Range 43 West of the 5th P.M. in Mills County, Iowa.

All of Sections 6, 7, 18, and 19; the Southwest Quarter of Section 5; the West Half of Section 8; the West Half of Section 17; the Northwest Quarter of Section 20; and the Northwest Quarter of Section 30, all in Township 72 North, Range 42 West of the 5th P.M. in Mills County, Iowa.

The Southwest Quarter of Section 31 in Township 73 North, Range 42 West of the 5th P.M. in Mills County, Iowa.

Section 2. Section 9.00 of Ordinance No. 334 is hereby amended to add thereto the following statement, "During the time this Ordinance is in effect, the Board of Adjustment shall consist of seven members, two members of which shall be residents of the area described in Section 1 of this Ordinance".

Section 3. Section 1 of Ordinance No. 315 is hereby amended by adding thereto the following statement, "During the time this Ordinance is in effect the Planning and Zoning Commission of the City of Glenwood, Iowa, shall consist of ~~seven~~ members, two of whom shall be residents of the area set out in Section 1 of this
