ORDINANCE NO. 389

AN ORDINANCE AMENDING ORDINANCE NO. 334 OF THE CITY OF GLENWOOD, IOWA, TO REZONE CERTAIN DESCRIBED REAL ESTATE FROM AG-AGRICULTURAL ZONE AND RS-84 SINGLE FAMILY RESIDENCE ZONE TO ZONE RS-72.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLENWOOD, IOWA:

1. That the following described real estate:

A part of the Northeast Quarter of Section 11, Township 72 North, Range 43 West of the 5th P.M., being all of Auditors Lots 45, 56, and 7 and part of Auditors Lots 4, 9, and 44, said tract being more particularly described as follows:

Beginning at the southwest corner of Auditors Lot 13 in the Northeast Quarter of Section 11, Township 72 North, Range 43 West; thence northerly along the west line of said Auditors Lot 13 to the north line of said lot; thence easterly along said north line to the southwest corner of Lot 17 Deitchler Addition (being the west line of Deitchler Addition); thence northerly along the west line of Deitchler Addition to the northwest corner of Lot 26 Deitchler Addition; thence northerly to the southwest corner of Lot 1 Harolds Addition; thence along the west line of Harolds Addition to the northwest corner of Lot 4 Harolds Addition; thence northeasterly along the north line of said Lot 4 to the west right of way line of Highway 275; thence northwesterly along said west right of way line to a point located 136.0 feet southeasterly of the north line of Auditors Lot 4 as measured along the west right of way line of Highway 275; thence westerly to a point 168 feet west of the centerline of Highway 275 along a line parallel to the north line of said Auditors Lot 4; thence northwesterly 136.00 feet along a line parallel to the west right of way line of Highway 275 to the north line of Auditors Lot 4; thence westerly along the north line of Auditors Lot 4 and 7 to the west line of Auditors Lot 7; thence southerly along the west line of Auditors Lots 7, 46, 45, and 44 to a point on the west line of Auditors Lot 44 which is the north line of Lot 43 projected west; thence easterly along the north line of Lot 43 projected to the east line of Lot 43; thence southerly to the north right of way line of 6th Street, thence easterly to the point of beginning

be and the same is hereby zoned RS-72 Single Family Residence; that the ground above described as being in Auditors Lots 44, 45, 46, and 7 was formerly zoned AG-Agricultural Zone and the remaining real estate described was formerly zoned as RS-84 Single Family Residence 8400 square feet zone.
