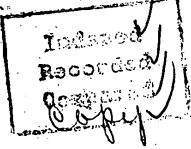


ORDINANCE NO. 483

AN ORDINANCE TO ADD TITLE II, DIVISION 3, CHAPTER 3,
TO THE 1977 CODE OF GLENWOOD, IOWA.



BE IT ORDAINED

SECTION 1. That Division 3 of Title II of the 1977 Municipal Code of Glenwood, Iowa, be, and the same is hereby amended by adding Chapter 3.

SECTION 3. That this Ordinance shall be in full force and effect from and after its final passage, approval and publication, as required by law.
