ORDINANCE NO. 553

AN ORDINANCE ADOPTING THE "CODE OF ORDINANCES OF THE CITY OF GLENWOOD, IOWA, 1993"

BE IT ORDAINED by the City Council of the City of Glenwood, Iowa,

SECTION 1. Pursuant to published notice and following public hearing on the $\frac{14 \, \text{th}}{380.8}$ day of $\frac{\text{December}}{\text{December}}$, 1993, so required by Sections 362.3 and 380.8, Code of Towa, there is hereby adopted by the City of Glenwood, Iowa, the "CODE OF ORDINANCES OF THE CITY OF GLENWOOD, IOWA, 1993."

SECTION 2. All of the provisions of the "CODE OF ORDINANCES OF THE CITY OF GLENWOOD, IOWA, 1993," shall be in force and effect on and after the effective date of this ordinance.

SECTION 3. All ordinances or parts thereof in force on the effective date of this ordinance are hereby repealed from and after the effective date of this ordinance, except as hereinafter

SECTION 4. The repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before the effective date of this cordinance; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money by the City or authorizing the issuance of any bonds of said City or any eviassumed by said City; nor shall said repeal affect the administrative ordinances or resolutions of the Council not in CORDINANCES OF THE CITY OF GLENWOOD, IOWA, 1993"; nor shall it affect the following ordinances specifically saved from repeal:
