** City Council Minutes, March 11th, 1914 **

The matter of extending the City Limits of the City of Glenwood was taken under advisement, and the following resolution presented for passage.

Resolution #356

Be It Resolved By the City Council of the City of Glenwood, Iowa, That the Boundaries of the said City of Glenwood, Iowa be extended as follows, to-wit:

Commencing at a point where the East line of Hazel Street intersects the south Corporation line, and running thence South on a straight line for eighty (80) rods, thence East to a point on the West line of Mills County Road No. Seven Hundred Four (704), thence North on the west line of the said County Road to a point on the South line of Mills County Road No. Fifty Five (55), thence along the South line of said CountyRoad #55 in a westerly direction to a point where the said south line of the said CountyRoad No. 55 intersects the East line of the present Right of Way of the Chicago, Burlington, & Quincy Railroad, thence Northeast for a distance of thirty (30) feet to the Corporation line in the center of the said Mills County Road No. 55.

Be It Resolved By The City Council Of The City of Glenwood, Iowa, That whereas said City Council of the City of Glenwood, Iowa, did on the 11th day of March, 1914, at a special meeting called by the Mayor, pass a Resolution extending the City Limits of the said City of Glenwood, Iowa, as follows: Commencing at a point where the East line of Hazel Street intersects the South Corporation line, and running thence South on a straight line for Eighty (80) rods, thence East to a point on the West line of Mills County Road No. Seven Hundred Four (704), thence North on the west line of said County Road on the South line of Mills County Road No. Fifty Five (55), thence along the south line of said County Road No. 55 in a westerly direction to a point where the said south line of the said County road No. 55 intersects the east line of the present Right of Way of the Chicago, Burlington, & Quincy Railroad, thence Northeast for a distance of thirty (30) feet, to the Corporation line in the center of the said Mills County Road No. 55.
