**Amendment to

In accordance with the terms and provisions of Section 17 of the Bylaws ("Bylaws") of Miracle Hills Park Place Condominium Association, Inc., a Nebraska non-profit corporation, the following amendment to the Bylaws is hereby adopted by the required ownership of units of the Association and the Directors of the Executive Board, and executed by the President, attested by the Secretary, executed by approving co-owners, and executed by approving directors.

Section 8 of the Bylaws entitled Executive Board shall be, and hereby is amended deleting the second sentence in the first paragraph and substituting the following sentence:

At least three of the five elected Directors of the Executive Board must be members of the Association as defined in Paragraph 3 above.

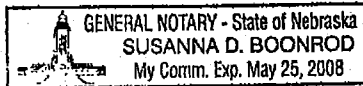


