This is to certify that I, WELLS FOSTER, the undersigned Registered Land Surveyor, have accurately surveyed and set iron pipe on all lot corners in Mission Heights Addition C, an addition to the City of Bellevue, Neb., as laid out to me on a tract of land in part of Lot 281, which lies wholly within the N.W. 1/4 of Sec. 36, T.14N., R.13E., of the 6th PM. Survey County, Neb., more particularly described as follows: The point of beginning being 533.25 ft. East of the West 1/4 corner of Sec. 36 along the 1/4 Sec. line and 164.6 ft.
