## FIRST AMENDMENT

TO

DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR

MISSION PARK, A SUBDIVISION IN DOUGLAS COUNTY, NEBRASKA

This Amendment to Declaration is made the 19 day of \_\_\_\_\_\_\_, 2009, by the Owners of more than Seventy-Five Percent (75%) of the Lots in Mission Park, hereinafter referred to as the "Owners."

## PRELIMINARY STATEMENT

By Declaration of Covenants, Conditions, Restrictions and Easements for Mission Park, a Subdivision in Douglas County, Nebraska, dated August 11, 1994, and recorded in the Douglas County Register of Deeds' Office in Book 1127 at Page 326 (herein, the "Declaration"), B.H.I. Development, Inc. (the "Declarant") imposed covenants, conditions, restrictions and easements on LOTS 172 THROUGH 329, INCLUSIVE, IN MISSION PARK, A SUBDIVISION, AS SURVEYED, PLATTED AND RECORDED IN DOUGLAS COUNTY, NEBRASKA.

Article II, Section I. of the Declaration currently provides as follows:

I. No primary flat or mansard roof shall be permitted or any residential structure. All residential structures shall be roofed with wood cedar shakes or wood shingles. Hardboard, bonded wood, pressed wood, imitation wooden shakes, or the like may be permitted with the express written approval of Declarant. Asphalt shingles will not be approved by the Declarant for coverage of any roof.

Article VI, Section B. of the Declaration currently provides as follows:

B. The covenants and restrictions of this Declaration shall run with and bind the land for a term of twenty-five (25) years from the date this Declaration is recorded. This Declaration may be amended by the Declarant, or

any person, firm, corporation, partnership, or entity designated in writing by the Declarant, in any manner it shall determine in its full and absolute discretion for a period of eight (8) years from the date hereof. Thereafter this Declaration may be amended by an instrument signed by the Owners of not less than seventy-five percent (75%) of the lots in the Properties.

The Owners desire to Amend the Declaration.

WHEREFORE, the Owners hereby amend the Declaration as follows:

- 1. Article II, Section I. of the Declaration is deleted in its entirety and the following is hereby substituted:
  - I. No primary flat or mansard roof shall be permitted on any residential structure. All residential structures shall be roofed with wood cedar shakes, wood shingles or asphalt shingles of 50-year guarantee or greater quality of weathered wood color (examples including, but not limited to, CertainTeed 50 year shingles, Tamko 50 year shingles, and Owens-Corning 50 year shingles). Upon express written approval of the Mission Park Homeowners Association Board (the "Board") or any authority designated by the Board, a residential structure may be roofed with alternative roofing materials of equal or greater quality as those permitted herein (including, but not limited to, hardboard, bonded wood, pressed wood, and imitation wooden shakes), but any such alternative roofing material must be either weathered wood or similarly earth-toned color.

Except as amended herein, the Declaration shall remain in full force and effect as previously recorded.


