WHEREAS, the City Council of the City of Omaha did, by Ordinance No. 13353, properly vacate the streets above described; and.

WHEREAS, said Ordinance No. 13353 provided for the reservation of easements in all vacated streets; and,

WHEREAS, the entire area above described has been included in the plat and dedication of North Ridge Heights, wherein new streets are provided for and property dedicated, which plat was approved and accepted by the City Council of the City of Omaha on April 14, 1959; and,

WHEREAS, the Public Works Department and the Planning Department recommend that the easements reserved in the aforement-ioned Ordinance No.13353 be waived;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That there be and hereby is vacated, so much of the following streets as are now located in the plat of North Ridge Heights: Hanover Street from 34th Street to west line of Blocks 200 and 201, Original City of Florence; Weber Street and Scott Street from 33rd Street to 36th Street; 34th Street from Scott Street to Hanover Street; 36th Street from South line of

Block 206 Ordiginal City of Florence to South line of diagonal road passing through Block 205 and along North line of Block 210, Florence, except part dedicated by Florence Field Addition; North Ridge Heights being comprised of the following area located in the Southwest Quarter (SW-1/4) of Section 28 and the Southeast Quarter (SE-1/4) of Section 29, Township 16, North, Range 13, East of the 6th P. M., Douglas County, Nebraska, to-wit:

> Beginning at a point 41.25 feet East of the NE corner of Block 213, Florence, said point being on center line of vacated 33rd Street, thence S 12015' E on center line of said vacated 33rd Street 654.08 feet to a point in the center line of vacated Scott Street, thence S $78^{\circ}02^{\circ}$ W on center line of vacated Scott Street 1034.6 feet, thence S 86°27'30" W 102.49 feet, thence S 78°02' W 287.52 feet to a point on the East line of North Ridge Drive, thence Northerly on the East line of North Ridge Drive and on a curve to the left (Radius being 540.0 feet) 207.35 feet, thence N 34021' W on the East line of North Ridge Drive 164.6 feet, thence on the East line of North Ridge Drive on a curve to the right (Radius being 458.25 feet) 897.91 feet, thence N 770 55° E on the South line of Forest Lawn Ave. 357.2 feet to the center line of vacated 34th Street, thence S 12050' ${\tt E}$ on the center line of vacated 34th Street 346.5 feet, thence N 770 55' E along the North line of Block 213 Florence, 735.88 feet to the point of beginning.

That that part of Ordinance No. 13353 in Section 2. conflict herewith be, and the same hereby is, repealed.

Section 3. That this Ordinance shall be in full force
