AN ORDINANCE vacating North 78th Street between Lexington Avenue and Colby Street and vacating Carlos Drive between Fairfax Avenue and Aylesworth Avenue, and retaining title to the street portions being vacated in the City of Lincoln, Nebraska.

BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

Section 1. That North 78th Street from the south right-of-way line of Colby Street to the north line right-of-way line of Lexington Avenue be and the same is hereby vacated, subject to title of said street portion being vacated remaining in the City of Lincoln, Nebraska.

Section 2. That Carlos Drive from the south right-of-way line of Aylesworth Avenue to the north right-of-way line of Fairfax Avenue be and the same is hereby vacated, subject to title of said street portion being vacated remaining in the City of Lincoln, Nebraska.

Section 3. That this ordinance shall take effect and be in force from and after its passage and publication according to law.


