**SECOND AMENDMENT TO
NORTHERN LIGHTS PROTECTIVE COVENANTS**

The undersigned party representing over two-thirds of the votes of the membership of the Corporation, hereby modify the Northern Lights Protective Covenants filed of record with the Lancaster County Register of Deeds on October 15, 1997 as Instrument No. 97-043082, as amended by the Amendment to Northern Lights Protective Covenants filed of record with the Lancaster County Register of Deeds on May 28, 1998, as Instrument no. 98-025787, by amending paragraph II, page 2, to add the following sentence:

During construction of any residence on a Lot, a dumpster shall be placed on the Lot and no material may be staged or stored in any street, road or on another Lot.

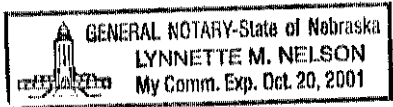
