EASEMENT FOR BURIED RIGHT-OF-WAY**

In consideration of mutual benefits to be derived from the facilities proposed hereinafter, and the further consideration of One (\$1.00) Dollar in hand paid, receipt whereof is hereby acknowledged, the undersigned owner of:

The Pacific Hollow Addition, SID #322 being a platting of the West 1/2 of the NW 1/4 of Section 26 and all that part of the SE 1/4 of the NE 1/4 of Section 27, all in T15N, R11E of the 6th P.M. in Douglas County, Nebraska,

do hereby grant and convey to T-V Transmission, Inc., a Nebraska corporation, and to its successors and assigns, the right to construct, reconstruct, perpetually maintain, and operate underground television lines, together with the necessary cables, wires, underground conduits, aboveground appurtenances, etc., with the right to enter said premises for the purpose of installing, repairing, replacing, operating, and maintaining and removing said television lines in, over and under the said property at about the following location:

A 10 foot wide strip of land adjoining Lots 57 through 67 and Outlot 3, and a 10 foot wide strip of land adjoining Lot 68 and Outlot 4 in the above addition.

The Grantee shall replace and/or repair any and all damage to improvements caused by Grantee exercising any of its rights in constructing, reconstructing, repairing, operating, and maintaining its underground television lines. In exercising any of its rights in constructing, reconstructing, repairing, operating, and maintaining its underground television lines, the Grantee shall also restore the surface of any soil excavated and shall cause the premises to be left in a neat and orderly condition.

This grant shall be binding upon the heirs, executors, administrators, successors, and assigns of the Grantors herein.
