**SECOND AMENDMENT TO THE  
 DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF  
 PACIFIC HOLLOW**

THIS SECOND AMENDMENT is made to the Declaration of Covenants, Conditions and Restrictions for Pacific Hollow, a subdivision in Douglas County, Nebraska, dated August 20, 1984 and recorded as Book 717 Page 54 in the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska on August 24, 1984 (hereinafter referred to as the "Declaration"), by the owners of not less than ninety percent (90%) of the lots covered by this Declaration (hereinafter referred to as the "Declarant," whether one or more).

**PRELIMINARY STATEMENT**

Article V, Paragraph B of the Declaration provides that the covenants and restrictions of the Declaration may be amended by the owners of not less than ninety percent (90%) of the lots covered by this Declaration.

NOW, THEREFORE, Declarant hereby declares that the Declaration of Covenants, Conditions, and Restrictions of Pacific Hollow, a subdivision in Douglas County, Nebraska, dated July August 20, 1984 and recorded as Book 717 Page 54 in the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska on August 24, 1984, should be and hereby are amended in the following manner:

1. By deleting therefrom Paragraph B of Article V and adding in its place and stead the following:

"The covenants and restrictions of this Declaration shall run with and bind the land for a term of twenty-five (25) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years unless terminated within the year prior to expiration by not less than seventy percent (70%) of the owners of the lots covered by this Declaration. This Declaration may be amended by an instrument signed by the Owners of not less than seventy percent (70%) of the lots covered by this

Declaration. Any amendment, modification or extension must be recorded in the office of the Register of Deeds to be effective.”

2. By deleting therefrom Paragraph I of Article III and adding in its place and stead the following:

“No primary flat or mansard roof shall be permitted on any dwelling. All dwellings shall be roofed with wood shakes or wood shingles, or other alternate equivalent or better material approved in writing by the Architectural Control Committee. The parts of all pre-fabricated metal furnace flues that protrude from the roof of a dwelling must be painted and no furnace flue may protrude more than five (5) feet from the roof of the dwelling, as measured from the top cap of the flue to the point from which the flue emerges from the roof. In the event that a dwelling is constructed without a fireplace, the furnace flue must then be faced with clay-fired brick or stone above roof level. All furnace flues must be located on the rear side of the roof ridge.”

All other terms of said Declaration shall remain in full force and effect.
