# EASEMENT AND AGREEMENT

This Agreement made on December 10, 2005 between Pioneer LLC, a Nebraska Limited Liability Company, hereinafter referred to as "Pioneer", and Pioneer Lake Homeowners Association, A Nebraska Non-Profit Corporation, hereinafter referred to as the "Association", and Don Rogert, hereinafter referred to as "Rogert".

A. Whereas Pioneer is the title owner of record of BOOK PAGE BOOK PAGE TO PAGE

and the NE 1/4 SE 1/4 of Section 12, Township 17
North Range 5, East of the 6<sup>th</sup> P.M., Dodge County,
Nebraska more particularly described on the attached
"Exhibit A" and "Exhibit B".

- B. Whereas the Association will become title owners of record of the property described in paragraph A., above;
- C. Whereas the Association has agreed to grant to Pioneer and/or Rogert a permanent easement or right of way over and under the following described property, to-wit:

Access Easement in Part of Tax Lot 94, Tax Lots 52, 79, 80 and North Shore Drive in Pioneer Lake Subdivision located in the SW 1/4 of Section 7, Township 17 North, Range 6 and the NE 1/4 SE 1/4 of Section 12, Township 17 North Range 5, East of the 6<sup>th</sup> P.M., Dodge County, Nebraska more particularly described on the attached "Exhibit C" and "Exhibit D".

It is therefore agreed as follows:

(a) Pioneer and/or Rogert shall have a permanent easement or right of way over and under the property described in Paragraph C, above. Such easement is granted as a perpetual easement for the following purposes:

- (1) Ingress and egress across the property for access to the property along and south of the Platte River dike and the property encompassing the future Phase 3 of the Pioneer Lake Subdivision development.
- (2) A perpetual utility easement, for the purpose of providing utilities to the future Phase 3 of the development.
- (3) To install, operate, maintain, repair, and replace a future water main that services the property in the future Phase 3 of the development, including the right to hook to the existing water main located within Phase 2 of the development.
- (4) To complete any and all construction work involved in completion of Phase 2 and Phase 3 of the development.
- (b) Such right of ingress and egress shall be exercised in a reasonable manner.
- (c) The Association, their successors or assigns, covenant that at no time will any buildings, structures, pipelines or other property, except walks, driveways or utility lines be erected, constructed, used or placed on or below the surface of the land described in Paragraph B that will interfer with the above granted easements.
- (d) Pioneer and/or Rogert shall restore the surface of the soil excavated for any purpose hereunder to the original contour thereof as near as may be in the event they are installing utility or water services.
- (e) Pioneer and/or Rogert agree that they will indemnify and save harmless the Association from any liabilities, claims for damages or suits for any injury to any person or property from any cause that arises out of their activities carried out on the above described property. Pioneer and/or Rogert shall provide proof of liability insurance in the amount of \$1,000,000 and name the Association as loss co-payee.

(f) The Association further agrees that there will be no charges or fees for Pioneers and/or Rogerts use and activities carried on under the above granted rightss-of-way and easements.

Such easements and rights of way shall be maintained and kept in repair by the Association and shall at all times be kept open for the use of Pioneer and/or Rogert. Such easements and rights of way shall run with the land and shall remain an encumbrance upon the property herein agreed to be conveyed for the benefit not only of Pioneer and/or Rogert but of any person or corporation which shall hereafter become the owner, assign or developer of the property to be accessed, the ownership of which is retained by Pioneer and/or Rogert and for the benefit of which such easements and right of way is reserved.
