## ORDINANCE NO. 450

AN ORDINANCE CREATING WATER-MAIN EXTENSION DISTRICT NOTICE 2005-1 OF THE CITY OF NORTH BEND, NEBRASKA; ESTABLISHING THE OUTER BOUNDARIES OF THE DISTRICT; DESIGNATING THE SIZE, LOCATION AND TERMINAL POINTS, AND ESTIMATE OF THE ENGINEER IN CONNECTION THEREWITH ON FILE WITH THE CITY CLERK

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF NORTH BEND, NEBRASKA, as follows:

Section 1. The Mayor and Council of the City of North Bend, Nebraska, pursuant to Neb. Rev. Stat. Section 18-401 et. seq., hereby find and determine that it is necessary and advisable to extend the municipal water service beyond the existing system by the construction of certain water mains, together with all necessary appurtenances thereto, and for the purpose of constructing said improvements there is hereby created Water-Main District No. 2005-1 of the City.

Section 2. The outer boundaries of Water-Main District No. 2005-1 shall include all of the following property to-wit:

See the Limits of District consisting of two pages which is attached hereto and incorporated herein by reference as if fully set forth.

Section 3. The water mains to be constructed in said District shall be water mains along with gate valves, fire hydrants and all other necessary appurtenances required to complete the project. The size, location and terminal points of said water mains are as follows:

At 10" water main commencing at the northeast corner of the intersection of 9th and Cottonwood Streets in the City of North Bend, Nebraska; thence west approximately 50 feet; thence south approximately 1,420 feet at which point the water main is reduced to an 8" water main; thence continuing south approximately 870 feet at which point it will be connected to an existing 6" water main.

Section 4. The engineer's estimate of the total cost of the proposed extension, have heretofore been filed with the City Clerk and the same are hereby accepted. It is hereby found and determined that none of the properties included within the foregoing district are served by the existing water system of the City and the land included within the District is located within the boundaries of the City or within one mile of the City limits.

Section 5. The engineer's estimate of the total cost of the projects is \$155,000.00.
