NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Hickman, Nebraska:

1. The application for administrative subdivision and waiver of lot size filed by William R. Scott and Laverne I. Scott on June 16, 2003, and incorporated herein by reference, be approved and the subdivision of land and waiver of lot size is granted.

2. Parcel 2 referenced in Exhibit 1 attached hereto is not a buildable lot and would need to be combined with additional acres to be a buildable lot.

3. The Municipal Clerk, as the designated agent of the governing body, is hereby directed to (i) cause all certificates of approval to be attached to the original and all copies of the lot split survey, maps, or drawings as may be required and submitted as part of said application; (ii) file a certified copy of said approved lot split survey and administrative subdivision and such other documentation as may be necessary with the Lancaster County Register of deeds office and the official designated to issue building or occupancy permits; (iii) furnish a copy of said documents to the applicants; and (iv) collect and pay all fees connected with such filing as may be imposed upon said subdivider.

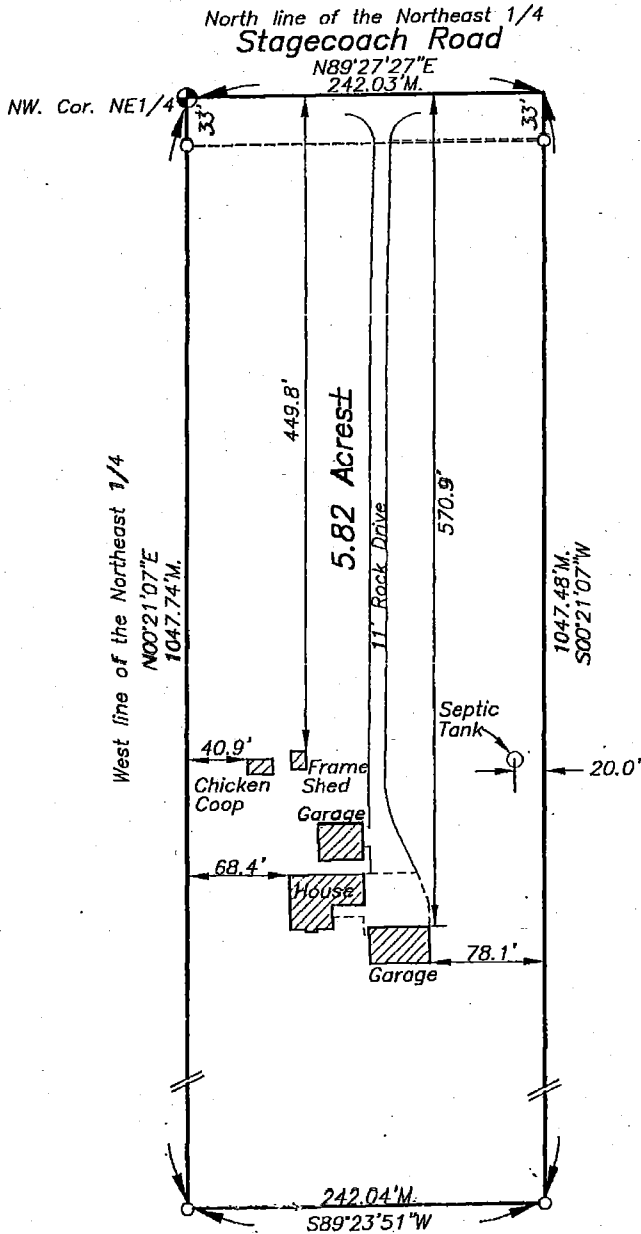
