DEDICATION AND EASEMENT

This DEDICATION AND EASEMENT is executed this 10<sup>th</sup> day of March, 1986, by the hereaftersigned landowners of certain real property situated in the Village of Arlington, Washington County, Nebraska.

WHEREAS, said landowners are owners of certain real property in Arlington, Washington County, Nebraska, with certain sewer or drain lines or pipes as well as the manhole cleanouts servicing same (hereinafter collectively referred to as "sewer lines") running on and below the surface of said real property; and

WHEREAS, said landowners wish to dedicate said sewer lines to the Village of Arlington and further grant said Village an easement upon their respective tracts or lots of real property hereinafter described for the purposes of maintaining same;

NOW, THEREFORE, and in consideration of the mutual covenants expressed herein, the hereaftersigned landowners do hereby convey, dedicate, grant, remise and otherwise quitclaim unto the Village of Arlington, Washington County, Nebraska, a municipal corporation, all of their and each of their right, title and interest in and to the sewer lines described on the attached Exhibit "A", said Exhibit "A" being specifically incorporated herein by this reference.

Said landowners do also, and BY THESE PRESENTS, hereby grant, sell, convey, remise, quitclaim and otherwise extend to the said Village of Arlington a permanent and perpetual easement of sufficient and reasonable width and length over and upon their respective tracts or lots of real property described on the said attached Exhibit "A" and such that said easement will include the full right, power and authority of said Village to maintain, repair, replace, install, alter or otherwise operate said sewer lines from time to time as said Village (or its assigns), and in its discretion, deems necessary and reasonable for the continued or continuing operation of said sewer lines, provided, however, that in the event said Village (or any of its employees, contractors, agents or representatives) should exercise its rights of easement hereto and otherwise come upon all or any portion of the real property described herein in furtherance of the exercise of its rights of easement, that Village shall restore, and to its prior condition, any property of the undersigned signatories (or their successors or assigns) altered by Village (or any of its employees, contractors, agents or representatives) in furtherance of or pursuant to Village's rights of easement and maintenance hereunder.
